1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform cleaning work, including furnishing all labor, material, equipment and services, for the U.S. Embassy Moscow. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the total fixed price for the service after all the services described in this solicitation have been satisfactorily performed.

1.1 VALUE ADDED TAX

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

2 SCOPE OF WORK

The purpose of this fixed price contract is to obtain brick wall cleaning and sealing services for real property owned or managed by the U.S. Government at the Embassy of the United States of America in Moscow. The Contractor shall perform these services in all designated spaces as described in this solicitation.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

2.1 EXISTING SITE CONDITIONS

The Embassy of the United States of America in Moscow has a requirement to clean and seal the external red brick walls on the Embassy compound at the following address: Moscow, Bolshoy Devyatinsky Pereulok, 8, Moscow, Russian Federation 121099.

2.2 GENERAL REQUIREMENTS

2.2.1 The Contractor shall complete all work, including furnishing all labor, material, equipment and services, unless otherwise specified herein, required under this contract.

2.2.2 All work and procedures shall be performed in conformity with the specifications and work requirements herein. All local and US work safety and health norms and standards apply to this contract.

2.2.3 All specifications and requirements are written in the statement of work and cannot be changed without the approval of the Contracting Officer (CO).

2.2.4 The Embassy reserves the right to inspect and test all the work under this contract at any time. If any of the work does not conform to the contract requirements and specifications, the Embassy may require the Contractor to perform the services again at no additional cost to the Embassy.

2.2.5 The Contractor shall provide submittals on each material and chemical to be used on the contract for approval.

2.2.6 The Contractor shall submit a work schedule, setting forth date, time, contents of work, personnel and time line to completion for approval by the Contracting Officer's Representative (COR).

2.2.7 The Contractor shall visit the work site at a time designated by the Contracting Officer and inspect the work area in order to understand the existing conditions and work requirements.

2.3 WORK DESCRIPTION

2.3.1 Work area

The work area includes:

- Area 1: the entire external brick surface of the west façade of the concourse building, including brick walls in the cafeteria court. The total area is approximately 930 square meters;
- Area 2: the entire surface of the brick walls in the grotto area near town house 1. The total area is approximately 175 square meters;
- Area 3: part of the brick wall at the south-west corner of the Marine house. The total area approximately 8 square meters. The area is elevated above grade level by approximately 10 meters;
- Area 4: part of the brick wall in turnstile area of the North gatehouse. The total area is approximately 6 square meters;
- Area 5: selected areas of external brick surface on the east façade of housing units 1 and 2. The total area is 60 square meters. Some areas are elevated above grade level by approximately 5 meters;
- Area 6: brick and concrete walls in the amphitheater area near the Marine House. The total area of brick wall surface is approximately 31 square meters. The total area of concrete wall surface is approximately 35 square meters.

2.3.2 Wall cleaning

2.3.2.1 The contractor shall clean the brick surfaces only in areas 1, 2, 3, 4, 5; brick and concrete surfaces in area 6; from salt deposits, rust stains, dirt, and other contaminants. The contractor shall estimate the amount of work necessary for removal of each individual type of contaminant during the site visit.

The total brick wall area is approximately 1210 square meters. The total concrete wall area is approximately 35 square meters.

2.3.2.2 The contractor shall use bristle (nonmetallic) brushes, appropriate chemicals and water for cleaning.

All chemicals to be used for cleaning shall meet US safety standards. The Contractor will be provided with a copy of the applicable standards upon request. In cases where contractor does not have United States certification for chemicals it is permissible for contractor to submit Materials Safety Data Sheets for the COR review and approval from OBO. No chemicals shall be used without COR's approval.

2.3.2.3 The contractor shall not use sandblasting for cleaning. The methods and materials used for cleaning must not change the structure of the wall surface, and must retain the natural look of the brick wall. The wall surface after the cleaning must have even and uniform appearance.

2.3.3. Wall sealing

After the cleaning phase is completed, the contractor shall seal the brick walls in areas 1, 2, 5, 6 with solvent-based penetrating siloxane brick sealer such as Rosa-Super or equal, per the manufacturer's instructions. The sealing material must retain the natural look of the wall. The wall surface after the sealing must have an even and uniform appearance.

The total area of brick wall to seal is approximately 1210 square meters.

All measurements stated in this Scope of Work are approximate. The Contractor will be allowed to perform an independent measurement during the site visit.

3 STANDARDS

The work must be done in accordance with the local standards ГОСТ P 51870-2002, TP 118-01, and СНиП III-4-80. The Contractor will be provided with a copy of these standards upon request.

4 MANAGEMENT AND SUPERVISION

4.1 The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff. The supervisor shall have supervision as his or her sole function.

4.2 The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.

4.3 The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

5 GOVERNMENT FURNISHED MATERIALS

None.

6 UTILITIES

Electricity (220 V AC, 50 Hz, single phase) is available at the work site. City water is also available from the faucet closest to work site. Electricity and water are provided at no cost to the Contractor during the work period. Both shall be utilized solely for the contracted work. Toilet facilities will also be provided by the Embassy.

7 CLEANUP OF WORK SITE

All debris produced during the work must be removed from work site by the Contractor on a daily basis. The Contractor shall perform a final clean-up of the work site upon completion of the work. The Contractor is responsible for complying with all the local industrial waste disposal codes and regulations.

8 SAFETY

8.1 The contractor is responsible for taking all necessary safety measures during the work performance.

8.2 The contractor assumes absolute responsibility and liability for any and all personal injuries or death and/or property damage or losses suffered due to negligence of the contractor's personnel in the performance of the services required under this contract. The contractor's assumption of absolute liability is independent of any insurance policies.

8.3 The Contractor shall provide employees with and require the use of safety equipment, personal protective equipment and devices necessary to protect the employee.

8.4 The Contractor shall immediately report each accident to the Contracting Officer's Representative.

9 DELIVERABLE SCHEDULE

9.1. No work on site shall be commenced without the CO approval. The actual project start date will be coordinated with the COR.

9.2. Contractor shall complete the contract work within **30 (THIRTY)** calendar days after the date the Contractor receives the Notice to Proceed. Any extensions of the work completion date must be authorized by the CO in writing.

9.3. Contractor shall start work on site when all materials are on site and shall work diligently to complete the work once it has started (i.e. no large breaks in work).

10 CONTRACTOR PERSONNEL

10.1. The Contractor shall provide personnel as needed to complete the services that meet the technical requirements in this Scope of Work.

10.2. The contractor shall insure that all personnel employed in the performance of the contract are qualified and possess the necessary licenses required in their respective trades. The Contractor shall be qualified (with all safety and due diligence training). Their credentials shall prove their qualifications with required licenses, etc.

10.3 The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

10.4 Standard of Conduct.

10.4.1 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty.

10.4.2 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

10.4.3 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

10.4.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

10.4.5 After the award, the Contractor has five calendar days to submit to the Contracting Officer a list of workers and supervisors assigned to this project for the Government to conduct all necessary security checks. It is anticipated that security checks may take 60 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Passport Copy

Failure to provide any of the above information may be considered grounds for rejection and/or resubmittal of the application. Once the Government has completed the security screening and approved the applicants a badge will be provided to the individual for access to the site. This badge may be revoked at any time due to the falsification of data, or misconduct on site.

10.4.6 While working on this project, the Contractor personnel will be escorted by an Embassy Security Escort. The ration is one escort for every six employees. All employees must be in the line of sight of the escort at all times. The Contractor must

consider this restriction as he develops his execution plan.

11 NOTICE TO THE GOVERNMENT OF LABOR DISPUTES

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

12 INSPECTION AND ACCEPTANCE

The COR, or his/her authorized representatives, will inspect from time to time the services being performed and the supplies furnished to determine whether work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

13 FINAL COMPLETION AND ACCEPTANCE

13.1 "Final completion and acceptance" means the stage in the progress of the work as determined by the Contracting Officer and confirmed in writing to the Contractor, at which all work required under the contract has been completed in a satisfactory manner, subject to the discovery of defects after final completion, and except for items specifically excluded in the notice of final acceptance.

13.2 The "*date of final completion and acceptance*" means the date determined by the Contracting Officer when final completion of the work has been achieved, as indicated by written notice to the Contractor.

13.3 FINAL INSPECTION AND TESTS. The Contractor shall give the Contracting Officer at least five (5) days advance written notice of the date when the work will be fully completed and ready for final inspection and tests. Final inspection and tests will be started not later than the date specified in the notice unless the Contracting Officer determines that the work is not ready for final inspection and so informs the Contractor.

13.4 FINAL ACCEPTANCE. If the Contracting Officer is satisfied that the work under the contract is complete (with the exception of continuing obligations), the Contracting Officer shall issue to the Contractor a notice of final acceptance and make final payment upon:

- Satisfactory completion of all required tests,
- A final inspection that all items by the Contracting Officer listed in the Schedule of Defects have been completed or corrected and that the work is finally complete (subject to the discovery of defects after final completion), and

- Submittal by the Contractor of all documents and other items required upon completion of the work, including a final request for payment (Request for Final Acceptance).

14 WORKING HOURS

All work shall be performed during **standard Embassy working hours, Monday through Friday, 9:00AM to 6:00PM.** Other hours, if requested by the Contractor, may be approved by the Contracting Officer's Representative (COR). The Contractor shall give 24 hours advance notice to COR who will consider any deviation from the hours identified above. Changes in work hours, initiated by the Contractor, will not be a cause for a price increase.

15 INSURANCE

15.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

15.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

15.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

15.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

15.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, and employees, or any other person, arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising therefrom, except in the instance of gross negligence on the part of the Government.

15.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

15.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

15.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of insurance prior to beginning work under this contract. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

16 LAWS AND REGULATIONS

16.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

16.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.





Area 1 (Planters)





Area 2 (near Townhouses)






