The U.S. Embassy in Sarajevo is seeking an individual for the position of Medical Officer in the Health Unit.

BASIC FUNCTION OF POSITION:

The physician provides outpatient primary care medical services at the Embassy Medical Unit. Works without close technical supervision and has full responsibility for planning and administering the health program at post, including at-post hospitalizations and medical evacuations. Serves as consulting and on-call physician for high-level VIP visits. During the absence of the Regional Medical Officer will provide medical supervision of the Medical Unit staff and be available for after-hours medical consultation and referrals.

QUALIFICATIONS REQUIRED:

All applicants are instructed to address each selection criterion detailed below with specific and comprehensive information supporting each item. **IMPORTANT: IF APPLICANTS DO NOT CLEARLY ADDRESS ALL POSITION REQUIREMENTS LISTED BELOW, THE APPLICATION WILL BE DISQUALIFIED.**

- (1) Must hold M.D. University Degree with specialization in either Paediatrics or Family Medicine. Must be able to write prescriptions for common medicines and controlled drugs.
- (2) Minimum three years of clinical experience in their primary care specialty with at least 50% of the provider's time involved in direct patient care during the last three years.
- (3) Must be fluent (speaking/reading/writing) in English and Bosnian/Serbian/Croatian (B/S/C) with the ability to present medical findings in a clear and concise manner to medical and non-medical personnel.
- (4) Thorough knowledge of the Microsoft Word and Microsoft Outlook is required.

SELECTION PROCESS

When fully qualified, U.S. citizen Eligible Family Members (USEFMs) and U.S. Veterans are given preference. Therefore, it is essential that the candidate specifically addresses the required qualifications above in the application.

TO APPLY:

Interested candidates for this position must submit the following for consideration of the application:

2. A current resume or curriculum vitae that provides the same information found on the UAE (see *section 3A below for more information*); **or**
3. A combination of both; i.e. Sections 1-24 of the UAE along with a listing of the applicant's work experience attached as a separate sheet; **plus**
4. Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application. Candidates who claim conditional U.S. Veterans preference must submit documentation confirming eligibility for a conditional preference in hiring with their application.
5. Any other documentation (e.g., essays, certificates, awards) that addresses the qualification requirements of the position as listed above.

If an applicant is submitting a resume or curriculum vitae, s/he must provide the following information equal to what is found on the UAE. **Failure to do so will result in an incomplete application.**
