PUBLIC SALE OF USED VEHICLES

The Embassy of the United States will hold a sealed bid sale to sell used vehicles. The sale will be held on Wednesday, April 16, 2014. Prospective bidders are welcome to view vehicles at the Embassy Warehouse Parking Lot located at #10 Rajlovacka Street from 09:00 to 12:00 hrs.

Sale conditions:

- The vehicles being offered for sale are sold in “as is” condition, with no guarantee or representation as to operating condition.
- Due to Embassy security regulations, to view vehicles and to access the parking lot, all visitors are required to bring a picture I.D. card and register at the entrance to the parking lot. Any visitor without I.D. document will not be allowed to access the parking lot.
- In order to participate in the auction, all prospective bidders must deposit 1,000 KM in advance to account number 502022000-030000682-2 (KM) at branch office of Raiffeisen Bank Bosna i Hercegovina located at Zmaja od Bosne Street. - Bid forms with a copy of the deposit confirmation receipt are due in sealed envelopes in the drop box located at the parking lot entrance by 16:00 on the same day of the auction. The winning bidders will be notified on Thursday, April 17, 2014.
- All payments will be due on Friday, April 18, from 14:00 to 15:00 hrs, at the U.S. Embassy Cashier (Roberta C. Frasurea #1) and must be made in cash (local currency only). No checks/cards or other ways of payment will be accepted. Prospective bidders are obliged to settle all customs and VAT fees.
- Unsuccessful bidders will be able to collect their 1,000 km deposit in full as of Monday, April 21, through the aforementioned bank account at Raiffeisen Bank. Deposits of the successful bidders will be kept until final payment is made.
- All vehicles must be removed no later than 16:30 on Tuesday, April 22, 2014. It is mandatory to present your invoice(s) while taking over the vehicle(s). All vehicles left after this date will be disposed of and no refund will be provided. All buyers must come and remove their vehicles. The Embassy will not make deliveries.
- The U.S. Government retains the right to reject any or all bids.
