I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is for installation of shatter resistant in Government Owned housing units in accordance with Attachment A.
- B. The contract will be for a one-year period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

II. PRICING

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

**Shatter Resistant Window Film Scope of Work**

The awarded vendor shall install 8mm shatter resistant window film (SRWF) on all residential windows in the properties identified in the Purchase Order. All windows shall be cleaned with soap and water before installation of the SRWF. The SRWF shall be flush with the window and conform to the dimensions, and must not contain bubbles or other blemishes.

**Installation Process:**

The awarded vendor shall conduct a survey of the residence by measuring all exterior windows and documenting the measurements of each window in all rooms. The awarded vendor will be paid based on the square meter measurements of each window treated with SRWF. The Embassy will provide the awarded vendor with an appropriate amount of SRWF to complete installation of SRWF in each identified residence. After receiving the SRWF, the vendor shall prepare the window film for installation by precutting the measures for each window recorded during the survey. The awarded vendor shall notify the Contracting Officer Representative (COR) when the measurements for a residence have been precut and are ready for installation. The COR will advise the awarded vendor of the date and time residences are available to receive the SRWF treatment.

The awarded vendor shall install the precut SRWF to each exterior window and notify the COR when a residence is completed. The COR will inspect the residence to ensure the SRWF is installed properly and without imperfection. The vendor shall submit invoices for payment to the COR following the COR's notification of satisfactory completion of the services.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
