Please note this solicitation is not ready to be issued as of this date. The Embassy of the United States in Serbia will launch the solicitation on the Embassy website when it is available.

The solicitation will be for the repairs of residential grounds and buildings owned by the Embassy in Belgrade.

These requirements may change depending on funding availability in forth coming periods. Major duties and responsibilities are to repair sidewalks at two residences, and the construction of a retaining wall, construction of a garden shed and supply and installation of an electrical panel at one residence.

All responsible sources may submit an offer, which shall be considered. The Government plans to issue the solicitation in August 2016.
