DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. GENERAL

A. The EXBS Program/ U.S. Embassy in Belgrade has a requirement for purchase of five (5) ATV's, snow tracks, snow plows and training, for donation to the Republic of Serbia's Border Police.

B. The requirement is for new equipment ONLY, NO grey market or refurbished products. Items must be in original packaging, never used, and not altered in any way. All bid prices must include shipping FOB Destination U.S. Embassy Belgrade Warehouse. No partial shipments are permitted, unless otherwise specified by the Contracting Officer at time of award.

II. SPECIFICATIONS

The Contractor shall deliver to the U.S. Embassy the following items, BRAND NAME – EXACT MATCH OR EQUAL to:

A. Five (5) each Polaris Sportsman Touring 850 4 stroke twin cylinder.

- Displacement: 850 cc
- Fuel type: BMB 95 or BMB 98
- Drive System: Selective (2x4 and 4x4)
- Transmission: Automatic PVT.
- Fuel system: Electronic fuel injection
- Starting system: Manual-key.
- Fuel tank capacity: 19 liters or more
- Seating: Two (2) seats.
- Rack or box capacity: Front 55 kg. + Rear 110 kg.
- Unbraked trailer towing capacity: 905 kg
- Hitch Towing Rating: 680.4 kg

B. Each ATV shall include and be delivered with the following optional equipment installed and ready to use:

Winch Warn 3.0 RT – 1 each
Front trunk plastic – 1 each
Handlebar protection – 1 each
Front and rear roll bar – 1 each
Tow hitch in back – 1 each
Safety helmet – 2 each
Protective gloves – 2 each.

C. Homologation. The ATVs must have the appropriate European and Serbia homologation as required by the laws of the Republic of Serbia.

III. WARRANTY

A. Manufacturer warranty is required for parts and labor on all components. If award is made to a vendor who is a non-manufacturer, the vendor will coordinate with the manufacturer for any warranty repairs/concerns.

B. Warranty shall be for 2 years on the vehicles, and 6 months on batteries.

IV. TRAINING

A. Types of training: the contract price shall include the following training for the equipment operators:

- 1) Free training for handling/operation of ATV for up to 10 students.
- 2) Free training on basic service of ATV for up to 10 students.
- 3) Free training for emergency-service in the field for operators up to 10 students.

B. Location for training: the training shall be provided in Belgrade, Serbia at a location to be determined after contract award

V. MAINTENANCE

A. REGULAR MAINTENANCE

Free first regular service at 10 hours/oil, synthetic motor oil and labor included.

B. EXTENDED MAINTENANCE

Extended Service contract: One service each 6 months for all five ATV's or a total of twenty (20) service to include all parts and labor for oil change, spark plug and air filters as required.

VI. DELIVERY LOCATION AND TIME

B. The contractor shall deliver all items not later than 60 days after date of contract award.

C. Any contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice of at least 5 working days will be required.

D. Delivery shall be made between the hours of 09:00 and 15:00 on regular work days, Monday through Friday.

- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
