1. Contractor shall deliver and install natural stone tiles over newly erected reinforced concrete retaining wall.
2. Contractor shall construct new grill that shall be same in size and style as the existing one. Finishing of the new grill shall be in natural stone tiles.
3. Contractor shall deliver and install floor heating in kitchen concrete pad. Heating shall be connected to the existing radiator heating.
4. In order to provide space for new kitchen cabinetry existing chimney shall be rerouted to corner of the kitchen.
