1. PERFORMANCE WORK STATEMENT

1.1 The American Embassy in Belgrade, Serbia has a requirement to replace old residential split-pack air conditioning units with new energy efficient units. This is a turn-key type project where the Contractor shall dismantle old units, supply new ones, install, test, turn-on and train the Embassy maintenance staff. All new air conditioners supplied under this order shall be with inverter technology and R410 refrigerant.

1.2 This is a firm fixed price contract payable entirely in RSD. Prices shall include proper disposal of environmentally dangerous substances where applicable. No additional sums will be payable for any escalation in the cost of materials, equipment or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. The contract price will not be adjusted due to fluctuations in currency exchange rates.

1.3 The contract will be for a period not to exceed 120 days from date of award.

1.4. QUALITY ASSURANCE PLAN (QAP).

1.4.1 Plan. This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the Contract. The role of the Government is to conduct quality assurance to ensure that Contract standards are achieved.

1.4.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

1.4.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract

Terms and Conditions-Commercial Items), if any of the services exceed the standard.

1.4.4. Procedures.

- a) 4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.
- b) 4.2 The COR will complete appropriate documentation to record the complaint.
- c) 4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- d) 4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- e) 4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- f) 4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- g) 4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.
- h) 4.8. Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

2. PRICING

The rates below include all costs associated with the supply and installation in accordance with the attached scope of work, and the manufacturer’s warranty including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead and profit.

3. VALUE ADDED TAX

The Government will not reimburse the Contractor for VAT under this contract. The Contractor shall not include a line for VAT on Invoices as the U.S. Embassy has a tax exemption certificate with the host government (See Section I, 652.232-70 Payment Schedule and Invoice Submission (Fixed-Price) (AUG 1999).

All invoices and payments to local companies shall be in local currency (RSD).

4. NOTICE TO PROCEED

After Contract award and submission of acceptable insurance certificates and copies of all applicable licenses and permits, the Contracting Officer will issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of Contract award unless the Contractor agrees to an earlier date) on which performance shall start.

5. DELIVERY LOCATION AND TIME

5.1 The contractor shall deliver 7 each 12,000 BTU units and 2 each 24,000 BTU units to the Embassy warehouse. Those units will not require installation. The address is:

5.2 The Contractor shall deliver all items stated in 5.1 above not later than 30 days after date of contract award.

5.3 Any Contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice of at least 1 day will be required.

## 1. EQUIPMENT AND INSTALLATION REQUIREMENTS

1.1. General. The American Embassy in Belgrade, Serbia requires the Contractor to remove old and supply and install residential split-pack air conditioner units. The supplied and installed units shall be with inverter technology and R410 refrigerant.

1.2. Specifications. All air conditioning units must meet the minimum specifications set forth below:

- a) Full DC inverter aided w/ rotary compressor
- b) DC inverter controlled fan motor
- c) 220 Volts / 50 Hz, single phase
- d) Freon R410a
- e) Energy efficiency range:
  - A+++ for 12.000 BTU
  - A++ for 24.000BTU
- f) Remote control
- g) Max. indoor unit noise level:
  - 12.000 BTU:(V/S/N/Sleep): 39/33/23/19 dB(A) ± 1
  - 24.000 BTU:(V/S/N/Sleep) 45/40/35/29 dB(A) ± 1
- h) Functions: Cooling/ Heating / Dehumidifying
- i) Heating energy efficiency (SCOP, W/W) – 5.1
- j) Cooling energy efficiency (SEER, W/W) – 8.0
- k) Operating range:
  - Operating temperature (heating) (T-T) -15 to 24 °C
  - Operating temperature (cooling) (T-T) -10 to 48 °C
- l) Electrically heated compressor pan
- m) Ability to operate with long tubing \
- n) Minimum 5 year warranty

1.3. Locations. All units for replacement are located in residences in the Belgrade metropolitan area. The exact addresses will be provided to the Contractor by the Contracting Officer's Representative (COR) at least 7 (seven) calendar days prior to the scheduled installation.

### 1.4. Performance Standards

It is expected that all aspect this SOW will be completed. Work will result in the system being in good working condition upon reactivation. All deliverables shall be completed on time under this agreement.

## 2. HOURS OF PERFORMANCE

2.1. The Contractor shall maintain work schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of

the Post. The Contractor shall deliver standard services between the hours of 9:00 AM and 5:00 PM Monday through Friday. Because most of this work will require complete electrical shutdowns of listed equipment, a significant portion of services shall be delivered during Weekend, between the hours of 9:00 AM and 5:00 PM on Saturday and Sunday.

No work shall be performed on US Government and local holidays.

### 3. ACCESS TO GOVERNMENT BUILDINGS AND STANDARDS OF CONDUCT

3.1. General. The Contractor shall designate a representative who shall supervise the Contractor's technicians and be the Contractor's liaison with the American Embassy. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purpose. Contractor employees shall have access to the equipment and equipment areas and will be escorted by Embassy personnel.

3.2. Personnel Security. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall be used on this Contract prior to their utilization. Submission of information shall be made within 5 days of award of contract. **No technician will be allowed on site without prior authorization. Note: this may include cleared personnel if advance notice of visit is not given at least one week before the scheduled visit.**

3.3. Vehicles. Contractor vehicles will not be permitted inside the embassy compound without prior approval. If you need to have vehicle access please submit your vehicle information (Make, Model, License Plate #) along with a written justification as to why access is necessary. This should be submitted to the COR at least three working days prior to the visit.

The Contractor and its employees shall exercise utmost discretion in regard to all matters relating to their duties and functions. They shall not communicate to any person any information known to them by reason of their performance of services under this contract which has not been made public, except to the extent necessary to perform their required duties in the performance of the contract requirements or as provided by written authorization of the Contracting Officer. All documents and records (including photographs) generated during the performance of work under this contract shall be for sole use of and shall become the exclusive property of the U.S. Government. No article, book, pamphlet, recording, broadcast, speech, television appearance, film or photograph concerning any aspect of the work performed under this contract shall be published or disseminated through any media, to include company or personal websites, without the prior written authorization of the Contracting Officer. These obligations do not cease upon the expiration or termination of this contract or at any other point in time. The Contract shall include the substance of this provision in all subcontracts hereunder.

#### 3.4 Standards of Conduct

3.4.1 General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance, and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

3.4.2 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR). The Contractor shall provide, to each employee and supervisor, uniforms and personal equipment. The Contractor shall be responsible for the cost of purchasing, cleaning, pressing, and repair of the uniforms.

3.4.3 Neglect of Duties. Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

3.4.4 Disorderly Conduct. The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

3.4.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances which produce similar effects.

3.4.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include but are not limited to the following actions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and misuse of weapons.

3.4.7 Key Control. The Contractor **will not** be issued any keys. Access to the work areas will be facilitated by Embassy maintenance staff.

3.4.8 Notice to the Government of Labor Disputes. The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

#### 4.0 PERSONNEL, TOOLS, CONSUMABLE MATERIALS AND SUPPLIES

The Contractor shall provide trained technicians with the appropriate tools and testing equipment for the performance of the installations and testing as required by this Contract.

##### 4.1 Superintendence by contractor

The entire operation of the contracted services shall be superintended by the Contractor's bilingual (English/**Serbian**) liaison. The liaison shall coordinate the performance of the contracted services with the needs of the Government.

The liaison, or a qualified assistant, shall be on duty throughout the normal operating hours of the Embassy. The liaison shall also superintend the performance of the contracted services on Saturdays, Sundays, and holidays if work is performed on those days.

4.2 Contractor furnished materials will include but not limited to appropriate tools, testing equipment, and personnel safety equipment.

4.3 Disposal of used Freon and airconditioners. The Contractor is responsible for proper disposal of toxic/hazardous substances. All materials shall be disposed of according to Government and Local law. After proper disposal the contractor must show proof of authorized disposal of these toxic/hazardous substances.

6.0 INSURANCE REQUIREMENTS

7.1 Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor’s personnel in the performance of this Contract

The Contractor’s assumption of absolute liability is independent of any insurance policies.

6.2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this Contract, whatever insurance is legally necessary. The Contractor shall carry the following minimum insurance:

6.3 Worker's Compensation Insurance. The Contractor agrees to provide all employees with worker's compensation benefits as required under local laws (see FAR 52.228-4 “Worker’s Compensation and War-Hazard Insurance Overseas”).

7.0 LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to insure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the Contract shall be payable by the Contractor without Government reimbursement.

STATEMENT OF WORK

US Embassy Belgrade  
Residential Split Pack Air Conditioning Replacement Project

**1.0 PURPOSE**

1.1 OVERVIEW – Removal, installation and other related services are required including all equipment, tools, labor, and materials.

1.2 REQUIREMENTS - Contractor shall provide, deliver and install new residential split pack air conditioning (A/C) units as follows:

- 1.2.1.1 Removal of the old units in accordance to attached schedule and transporting them to the U.S. Embassy Warehouse. Removal of A/C's shall be executed in such a manner that shall prevent any Freon to be released freely into the atmosphere. Old installations shall be replaced where required in accordance to attached schedule. Newly installed copper tubing, where required, shall be protected with thermal insulation (Armaflex -brand name or equal). All units shall be removed and transported carefully without damaging them.
- 1.2.1.2 Where old pipe installations are going to be used, contractor shall flush all the piping using nitrogen/R141b or environmentally friendly equivalent.
- 1.2.1.3 All penetrations and damage to the masonry shall be repaired, patched, painted and restored to its original condition.
- 1.2.1.4 All mounting brackets shall be replaced with new, corrosive resistant, manufacturer recommended ones.
- 1.2.1.5 All installed condensation hoses shall be flushed prior to A/C connection. Where required new condensation hoses shall be placed in PVC panduit or embedded into the masonry walls as directed by the Embassy representative and in accordance to the city of Belgrade regulations.
- 1.2.1.6 All installed copper tubing and condensation hoses shall be tested for leaks after installations are completed.
- 1.2.1.7 Electrical feed shall be used from removed A/C locations. Contractor shall install new cables, panduits, junction boxes, plugs, circuit breakers where needed. Electrical installation shall be sized and executed in accordance to manufacturers requirements.

- 1.2.1.8 Contractor shall take all necessary precautions to protect work in progress, all property, persons, utilities, and buildings from any damage that might be incurred during this Contract.
- 1.2.1.9 The Contractor shall progressively clean the work site of debris and rubbish as the work proceeds.

## **2.0 REQUIREMENTS**

2.2 Installation – The Contractor shall carry out the installations, as described in item 1.0 above, in accordance with the approved final documents - manage, administer, supervise and inspect the project. The coordination and supervision of all work shall be the responsibility of the Contractor. All work has to be executed with minimal disruption to the operations on the work site.

2.3 COORDINATION – The Contractor shall coordinate the project requirements with Contracting Officer's Representative (COR). All contractual agreements or changes affecting the SOW and scheduled delivery of the project must be reviewed and agreed to in advance.

2.4 REVIEW COMMENTS - Comments provided to the Contractor resulting from FAC technical reviews shall be resolved, in writing within 3 days. Address each comment as either acceptable, disagree, or no response required.

2.5 LIFE SAFETY PROTECTION – The work shall meet OSHA standards - <http://www.osha.gov/>

Special precaution shall be taken during work requiring scaffolding and at high locations.
