1.0 GENERAL INFORMATION

The U.S. Consulate General Shanghai has a requirement to add to or replace the existing system furniture in two offices located on the U.S. Consulate General compound at 1469 Huai Zhong Lu. The project will include the fabrication and installation for the new systems furniture and potential disassembly of the current work stations.

2.0 PROJECT DESCRIPTION

Office #1:

- a. The existing office has nine (9) system furniture work stations with storage and a conference table. The existing work stations measure 3.0625 sqm each.
- b. The new office configuration needs 11 system furniture work stations and storage either using all or part of the existing system furniture, or replacing the entire system. Note: the conference table will be removed.

Office #2:

- a. The existing office has four (4) existing system furniture work stations with storage.
- b. The contractor will develop a layout to install the maximum number of workstations to fit in the space, while leaving room for necessary storage space (minimum workstation size 2.25 sqm). Contractor may provide options for review.

General requirements:

- Each workstation should be an L-shaped desktop with a movable drawer unit with one file-size drawer. Must be able to accommodate stand/sit attachment.
- Maximize storage with lateral files and overhead storage cabinets where appropriate.
- Maximize functionality of workstations with back panels for push pins and/or white boards.
- Layout and materials should encourage noise reduction when possible.
- Materials should be durable and good quality
- Power and data shall be able to enter the system from floor at the base or from the wall at the base without the use of power poles.
- If space allows include a small meeting table for 4 seats.
