I. OFFICE SUPPLIES DELIVERY

Customers with a section code will be able to place the order on line or via email through the contractor's internet address. The contractor will provide monthly invoices including all delivery notes for applicable month. The invoice shall state separately prices for orders place by individual sections (using section code) and VAT. The section codes will be provided at the time of award.

II. Minimum/Maximum Quantities

For each effective year of the purchase order, the U.S. Government guarantees a minimum order of **Euro 5,000.00** under this purchase order. The maximum amount ordered under each year of the purchase order will not exceed **Euro 15,000.00**.

Orders may be issued orally by the Contracting Officer, but will be confirmed in writing within three business days of the date the order is placed.

III. Delivery Location and Time

The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice **1 of working day** will be required.

E. If delivery will be to U.S. Embassy, the contractor shall deliver during working days between the hours of **10:00 - 12:00**.

V. Periods of Performance

The base period of this purchase order starts on date of award and continues for twelve months, with 2 (two) options to renew.

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from date of award through base period or option periods if exercised.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

52.216-19 ORDER LIMITATIONS (OCT 1995)

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than Euro 1, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) Maximum order. The Contractor is not obligated to honor--

(1) Any order for a single item in excess of than **Euro 5000**;

(2) Any order for a combination of items in excess of than **Euro 5000**;

or

(3) A series of orders from the same ordering office within than **2** days that together call for quantities exceeding the limitation in subparagraph (1) or (2) above.

(c) If this is a requirements contract (i.e., includes the Requirement clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) above.
