1. Price and Payment

1. 1 The contractor shall provide *language instruction services in the Slovak language* at an estimated number of 900 classes per prospective instruction period, i.e. September through July (approx. 42 training weeks resulting in 2-5 sessions per week and per contractor, depending on the number of contractors), to be given at a firm fixed price per session as identified below. Sessions shall be 60 minutes in length and shall be scheduled between Monday and Friday, 8:30 a.m. to 5:00 p.m. No more than five students will be part of any class, unless mutually agreed upon by the Contractor and the Government.

It is assumed that no language classes will occur in August. If there is a need for classes during this month, the estimated number of classes per contractor will increase accordingly.

Classes will get scheduled in close co-ordination with the Contracting Officer's Representative U.S Embassy for the following locations:

US Embassy, Hviezdoslavovo nam 4, 811 02 Bratislava, Slovakia.

If one of the two contracting parties is not available for training, classes shall be cancelled within 24 hours before begin of class (at least until COB the day before the scheduled class). Group sessions will be held at a minimum of one student.

#### MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of 100 sessions per year and contractor. This reflects the contract minimum for the period of performance. The amount of all orders shall not exceed 900 sessions per year and contractor. This reflects the contract maximum for the period of per performance.

#### 1.2 PAYMENT

The Contractor shall not submit an invoice for payment until all requirements identified in this contract have been completed and delivery to the COR is complete. The COR shall calculate the number of words which the contractor shall include in its invoice.

#### Definitions

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

## 2. PERFORMANCE WORK STATEMENT

The Contractor shall provide Slovak language instruction to adult students that focuses on job-relevant terminology (political, economic, consular, management, etc.) as well as cultural lessons and topics of general interest typically found in Slovak-language mass-media publications. Instruction shall be based on proficiency, communication, and academic principles as used at the Foreign Service Institute at the Department of State.

The Office of Personnel Management shall define the language proficiency levels identified as desired outcomes. All students shall be measured on their language proficiency levels in accordance with the Foreign Service Instituted Language Proficiency Test. The Contractor shall develop instructional materials as needed to encourage the development of speaking (including to the media, for advanced students), listening, and reading skills.

## 3. PERIOD OF PERFORMANCE

3.1 Classes shall be 60 minutes in length for **beginners** classes and 60 minutes for **intermediate** and **advanced** classes.

3.2 The Contractor will perform based on a schedule provided by the COR. Classes will take place min. twice a week and shall be scheduled between Monday and Friday 8:00 am to 6:00 pm. Depending on the number of students at post, the **Contractor must be available to teach at least two classes at different times of the day during each work day. In addition, the Contractor must be able to accommodate reasonable requests for a change in venue or the scheduled time.**

3.3 **Field trips shall be considered voluntary. If both the students and the contractor agree, the contractor shall be responsible for organizing field trips in close coordination with the COR.**

No more than 2-3 field trips per contractor shall be organized per year.

The students will bear their own cost associated with such field trip.

Payment to the contractor for such field trips to cover the expenditure of time will be made at the session rate – no extra expenses shall occur. **The duration per individual field trip shall not exceed 3 day and the incidental contractor's cost has to be predetermined and approved by the Post Language Officer.**

## 4. CONTRACTOR FURNISHED PROPERTY

4.1 The Contractor shall provide all instructional materials including texts, class exercises, handouts, tests, and audio-visual media.

4.2 The contractor shall replenish such expendable/consumable items as needed to provide for the performance of the work.

Prior approval of the U.S. Government is required to bring into a U.S. Government facility any required electronic equipment (such as CD or DVD player, laptop or USB stick).

- 4.3 The Contractor shall provide qualified instructor(s), who are well versed in all topics to be covered, capable of answering in-depth questions on each topic, will provide the required training in a classroom setting, based on the schedule of training modules or lessons and the objectives and goals for that training.
- 4.4 The Contractor shall provide other required classroom materials such as newspapers, magazines, dictionaries, or photocopied materials, written in the designated language for use by students in exercises or testing.

## 5. SPECIFIC TASKS

The contractor shall provide instructional Foreign Language Training services at the firm fixed prices shown in this contract. The objective of each training module or lesson is to prepare all students as efficiently and effectively as possible to accomplish the goals of the training.

The Contractor shall develop the linguistic competency needed for personnel or dependents, similar to what is provided by the Foreign Service Institute for students to attain the proficiency levels in speaking and reading identified in each task order

### GOALS OF FOREIGN LANGUAGE TRAINING

The goal of training is to provide the student with the skills and knowledge necessary to rapidly reach the desired level of performance as identified in the training modules or lessons identified below. Each student, at the completion of training, shall be able to perform at the required level of proficiency.

### ORAL RECOGNITION AND RESPONSE MODULE, LESSON 1

Each student, at the completion of training, shall be able to perform at the required level of proficiency.

### For beginners: RECEPTION AND INITIAL CONTACT, BEHAVIOR 1

When addressed in Slovak, the student will be able to recognize designated commonly encountered phrases and questions with the Slovak speaking public. The student must then respond appropriately, providing acceptably worded and pronounced verbal responses, answering the questions asked, or providing information as needed. At least 90% of the students completing training will be able to recognize and respond appropriately to at least 95% of the selected vocabulary, in 95% of the occurrences in which the selected vocabulary is presented.

### For intermediate/advanced students: SOCIAL CONVERSATION, BEHAVIOR 2

When engaged in social conversation, the student will be able to communicate with the Slovak speaking public, carrying on an appropriately worded and pronounced dialogue in the correct dialect and grammar. At least 85% of the students tested in

each class shall be able to answer correctly at least 90% of the selected vocabulary questions when used in conversational exchange.

### 5.1.2 READING COMPREHENSION MODULE, LESSON 2

For Beginners: RECOGNITION AND SUBJECT MATTER COMPREHENSION, BEHAVIOR 1

The student will be able to recognize designated key phrases or questions in Slovak, from the selected vocabulary when reading written communication or letters. The student must then respond appropriately, providing the requested information by selecting the correct reply, or by properly identifying the functional organization for whom the written communication was intended. At least 85% of the students completing training for each class will be able to comprehend and appropriately respond to or determine the intended addressee for at least 90% of the written communications in which the selected vocabulary is presented.

For intermediate/advanced students: TRANSLATION, SUMMARIZATION, AND RESPONSE SELECTION, BEHAVIOR 2

After reading communications, messages, or letters written in Slovak, the student will be able to comprehend, translate, and correctly summarize the purpose and content of the written communication that was provided. The student must be able to translate the requested information or pre-planned reply, and prepare a response to the selected communication. At least 75% of the students completing the training shall correctly recognize, comprehend, and summarize the written communication, and to translate the correct response to the written communication at least 85% of the time.

### 5.1.3 STUDENT TESTING

The contractor shall work with each student to identify specific language goals, to improve to required level (3/3), or improve conversational or public speaking skills.

The contractor shall administer tests on knowledge and proficiency as a required element of evaluating the student's progress in the training module or lesson. The contractor shall provide these tests periodically to:

- determine the student's progress in training;
- identify areas of weakness where supplemental training may be needed; and,
- quantify the student's then-current level of knowledge and proficiency.

Initial testing will be used to establish a baseline for measurement of knowledge and proficiency obtained, and may be used in a predictive manner to facilitate personal training planning.

The contractor shall use tests, including Computerized Adaptive Testing, which are approved by the Post Language Officer.

#### 5.1.4 STUDENT PROGRESS DOCUMENTATION AND TRAINING RECOMMENDATIONS

The Contractor shall be responsible for documenting each student's training progress, and for preparing training recommendations for each student at least once every three months. The recommendations may state specific plans for remedial, or supplementary use of supportive training materials, or use of tutoring and personalized training techniques

#### 5.1.5 STUDENT COUNSELING

The student will receive the above mentioned regular updates on his/her progress and will be given a chance to discuss the findings with the instructor(s) in order to develop the most effective individual development plan. The counseling sessions should result in specific tasking for remedial, or supplementary use of supportive training materials, or use of tutoring and personalized training techniques, as needed to improve student performance. The training recommendations will be documented.

#### 5.1.5 STUDENT ATTENDANCE

If a student is unable to attend a class, he/she is obliged to notify the Contractor directly no later than 6 pm day before the lesson either via phone or SMS. Class will take place as long as there is at least one student in attendance. It is the student's responsibility to make up for any missed class or, in the case multiple classes missed due to sickness or other unavoidable circumstances, to request individual coaching to catch up with the rest of the class.

The Contractor will prepare an attendance sheet for each class. The copy of the sheet including the attendees' signature will be an inseparable part of the invoice.

7.1 Quality Assurance and Surveillance Plan (QASP). This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

7.1.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

7.1.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection

clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

#### 7.1.4 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(D&B has no affiliation with this 4-character suffix.) (b) (1) The Contractor shall be registered in the **SAM** database prior to submitting an invoice and through final payment of any contract, basic agreement, basic ordering agreement, or blanket purchasing agreement resulting from this solicitation.

(2) The **SAM** registration shall be for the same name and address identified on the contract, with its associated CAGE code and DUNS or DUNS+4.

(3) If indicated by the Government during performance, registration in an alternate system may be required in lieu of SAM.

(c) If the Contractor does not have a DUNS number, it should contact Dun and Bradstreet directly to obtain one.

(f) The Contractor is responsible for the accuracy and completeness of the data within the **SAM** database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the **SAM** database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the **SAM** database to ensure it is current, accurate and complete. Updating information in the **SAM** does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (b) Certification. By submitting this offer, the offeror certifies that it is not:

(1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,

(2) Discriminating in the award of subcontracts on the basis of religion.
