**PERFORMANCE OF WORK STATEMENT**

The purpose of this contract is management of diplomatic post office (DPO) mail and diplomatic pouch shipments in accordance with the scope of work described herein.

**Incoming DPO Mail and Diplomatic Pouches** (Post prograde shipments: DPO mail and Diplomatic Pouch from the USA to Ljubljana)

It is the contractor's responsibility to pick up the incoming DPO mail and Diplomatic Pouch items from the warehouse facilities at the Ljubljana International Airport, facilitate the Slovene customs clearance, transport the shipment to the embassy compound at Prešernova 31, Ljubljana and offload upon arrival.

Shipments are to be delivered to the embassy compound under the following schedule:

- April through January: three times per week (Monday, Wednesday, Friday)
- February and March: two times per week (Wednesday, Friday)

Weekly schedule will be confirmed and forwarded to the contractor by the COR no later than every Thursday for the following week.

For all incoming shipments, the service provider shall accept the AV-7/CN38 documentation from the airport warehouse facilities representative and tender to Slovenian customs authorities as required and to U.S. Embassy representatives as required.

There is no specific flight information available. Pouch bags arrive on several flights daily and are to be picked up three times per week as noted above.

\* Post prograde contracts are negotiated by the Department of State in Washington D.C. and are subject to change. U.S. Embassy in Ljubljana will notify the service provider of any changes when they occur.

**Outgoing DPO Mail and Diplomatic Pouches** (Post retrograde shipments: DPO mail and Diplomatic Pouch from Ljubljana to the USA):

It is the contractor's responsibility to pick up the outgoing DPO mail and Diplomatic Pouch items from the embassy compound at Prešernova 31, Ljubljana, transport the shipment to the warehouse facilities at the Ljubljana International Airport, facilitate the customs clearance process and offload upon arrival.

Shipments are to be picked up at the embassy compound under the following schedule:

- January through December: three times per week (Monday, Wednesday, Friday)

Weekly schedule will be confirmed and forwarded to the contractor by the COR no later than every Thursday for the following week.

The retrograde contract for DPO is currently with Air France.

The current retrograde contract for Diplomatic Pouch is with Air France (95%) and DHL (10%).

\* Retrograde contracts are negotiated by the Department of State in Washington D.C. and are subject to change. U.S. Embassy in Ljubljana will notify the service provider of any changes when they occur.

**General Conditions of Carriage Shipments**

Consignments to be transported by the service provider will be and packed in a closed container, appropriate for the contents in order to ensure adequate protection against weather, vibration, pressure, and shock incurred during transport. The outgoing consignments will be prepared by employees of US Embassy in Ljubljana, Slovenia. The incoming consignments will be prepared by individuals working for US Diplomatic Pouch Office and shipped via designated carrier.

The Service Provider is required to complete the following tasks to satisfactorily accomplish required services:

- The Service Provider shall facilitate all required Slovene customs clearances for all U.S. Embassy (AV-7/CN-38 DPO mail and 7600 reports for Diplomatic Pouch).
- The Service Provider shall ensure that all DPO mail is secure until delivered to the airport warehouse facility.
- For all outgoing DPO mail, the Service Provider shall accept the shipment documentation from the Embassy and tender it to the warehouse facility representative. The Embassy shall provide shipment documents for all outgoing DPO mail and Diplomatic pouch shipments.
- The Service Provider shall deliver and/or collect shipments during embassy regular working days between 08:30 to 11:30.  
NOTE: Incoming and outgoing shipments may be picked up/delivered during one round trip. The holiday schedule of the Embassy is listed under 652.237-72. On these designated days the Service Provider will not be required to handle DPO mail or diplomatic pouches.
- The Service Provider shall keep daily records of the number of the Embassy's DPO mail and Diplomatic pouch items, weights, and dates posted and if necessary report any discrepancies between what is reported on documentation forms and what is actually received from the airport warehouse facility. Specifically, if during transit an entire shipment cannot travel together or a piece of shipment is misplaced.
- The Service Provider will take all due care to prevent breakage or damage to incoming and outgoing DPO mail and Diplomatic pouch shipments.
- The Service Provider shall be able to provide backup equipment and trained backup staffing to provide the contracted level of service in case of equipment breakdowns or personnel absences.

**Estimated Quantity of Shipments**

The Government estimates that there will be approximately 1,000kgs per month (12,000kgs per annum) of combined outgoing and incoming DPO mail and Diplomatic pouch shipments.

**Nature and Contents**

Consignments will normally contain:

- a) Letters, commercial and banking documents;
- b) Printed papers and business in general;
- c) IT equipment and supplies
- d) Checks and bills exchanged between authorized financial institutions, in accordance with the foreign exchange regulations;
- e) Goods, spare parts etc..

**Prohibitions**

The following items are prohibited in consignments:

- a) Any consignments which may cause a danger to the officers or soil or damage other items or equipment;
- b) Consignment containing coins, bank notes, platinum, gold or silver whether manufactured or not, precious stones, jewels and other valuables; (*jewelry is not prohibited*)
- c) Drugs and psychotropic substances;
- d) Living animals;
- e) Explosive, flammable and other dangerous material;
- f) Obscene or immoral items

### Standards of Weights and Dimensions

The individual pouches should not exceed thirty-one point eight (31.8) kilograms. Regarding the dimensions, the total sum of the length and of the greatest circumference measured in a direction other than the length is limited to 3 meters; length shall not exceed 1.50 m.

### Guarantees and Responsibilities

The service provider shall be responsible for the transportation, customs clearance and handling of DPO and Diplomatic Pouch shipments between the US Embassy Compound and Ljubljana International Airport warehouse facilities.

### Theft, loss and damage

The service provider shall be responsible in case of theft, loss or damage of the shipment when caused by the service provider mishandling, damage or negligence in proper and safe handling of DPO and Diplomatic pouch shipments.

### Claims

Any claim shall be notified in writing, along with proof of damage. This written notification should be sent to service provider within eight (8) days from the date of delivery of the item or the expected date of delivery, in case of delay or loss.

### QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

## 3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
