Updated Security Message for U.S. Citizens:
Demonstrations in Ljubljana on April 27th

U.S. Embassy Ljubljana informs U.S. citizens that a demonstration is scheduled to take place in Ljubljana on Saturday, April 27th. The protest will begin at 11:00 at Kongresni Trg. At 13:00, the protestors will likely move in the direction of City Hall and the European Commission before continuing onwards to Trg Republike and Parliament. At 15:00, a subsection of the protestors will gather in Kongresni Trg and then possibly march towards the U.S. Embassy. The demonstration is being organized by the All Slovenian Uprising, whose supporters have staged rallies around the country calling for Slovenia's "political elites" to step down. April 27th holds symbolic meaning (the formation of the liberation front during WWII) and it is anticipated that several thousand people may attend the event. During protests last fall, firecrackers and other objects were thrown at the police, who responded by using tear gas to disperse agitators. Several protesters were arrested and some minor injuries occurred.

We encourage U.S. citizens to take caution and exercise appropriate security measures. Be aware of your surroundings. Even demonstrations intended to be peaceful can turn confrontational and escalate into violence. You should avoid areas of demonstrations, and exercise caution if in the vicinity of any large gatherings, protests, or demonstrations.
