



## Partnership to Fight HIV/AIDS in South Africa

The United States is proud to be supporting South Africa's leadership in the fight against HIV/AIDS. On December 14, 2010, U.S. Secretary of State Hillary Rodham Clinton joined South African Minister Maite Nkoana-Mashabane to sign a Partnership Framework, which provides a five-year joint strategic plan to fight HIV/AIDS. PEPFAR's financial and technical assistance will support the leadership and implementation capacity of the South African Government and civil society, improving the effectiveness, efficiency, and sustainability of the response. By the end of the five-year period, the collaboration is expected to result in greater prevention efforts and expanded services for HIV and TB, and in a strengthened national health system.

### Saving Lives: PEPFAR Program Results

Progress achieved in South Africa through direct PEPFAR support during fiscal year (FY) 2011:<sup>1</sup>

- 1,139,500** individuals receiving antiretroviral treatment
- 2,400,000** HIV-positive individuals who received care and support (including TB/HIV)
- 556,600** orphans and vulnerable children receiving support
- 720,100** pregnant women with known HIV status received services to prevent mother-to-child transmission of HIV (PMTCT)
- 236,100** HIV-positive pregnant women received antiretroviral prophylaxis for PMTCT
- 6,850,200** individuals received counseling and testing



#### HIV/AIDS in South Africa

Adult (15–49) HIV prevalence, 2009: 17.8%<sup>2</sup>  
 Estimated adults and children (ages 0–49) living with HIV, 2009: 5,600,000<sup>2</sup>  
 HIV-related deaths, 2009: 310,000<sup>2</sup>  
 Orphans due to AIDS, 2009: 1,900,000<sup>2</sup>  
 Estimated antiretroviral coverage based on WHO 2010 guidelines, 2009: 37%<sup>3</sup>  
 Estimated percentage of pregnant women living with HIV who received antiretrovirals for PMTCT, 2009: 88%<sup>3</sup>

An intervention or activity is considered to be direct support if it can be associated with counts of uniquely identified individuals receiving prevention, care, or treatment services at a unique program or service delivery point benefiting from the intervention or activity.
