The vehicle partially described below is a **Toyota Fortuner 3.0 Diesel**. We will accept vehicles with certifiably equivalent specifications as a **Toyota Fortuner 3.0 Diesel**.

An award will only be made to a company which provides a vehicle for which factory original parts are available in Dar Es Salaam and throughout the rest of Tanzania. Certified factory trained technicians and factory certified support services must be available in Dar Es Salaam.

Please send quotations for 2 each of the vehicles mentioned.

Vehicle should have the following specifications at a minimum.

- The vehicle must be suitable for use in very rough, slippery, and steep conditions, such as those found in the bush in Africa.
- Full-time 4WD
- 5 speed manual dual range transmission
- Double wishbone front suspension
- Front disc brakes. Rear drum brakes.
- 5 doors
- 7 seats with outer seats with 3-point seatbelts. Center seats may have 2-point seatbelts. All seats facing forward.
- Front and rear bumpers and mud guards
- Carpeted floors
- Fabric seats
- Head rests
- Air-conditioning
- Tilt steering wheel
- Warning chime for oil, seatbelts and door-ajar
- Speedometer in kilometers/hour
- Normal gauges such as water temperature, etc.
- Lockable spare mounted under the body
- Tool kit and jack
