MAJOR RESPONSIBILITIES:

A. Program Management (30%)

- Provide oversight and program management support to the PMI team in implementing malaria program activities; in consultation with the Director, RDMA/OPH, the Malaria Specialist will be required to communicate regularly and work jointly with other members of the USAID RDMA health team, USAID/Washington Global Health Bureau and PMI team, and CDC Atlanta;
- Provide technical support on malaria within RDMA's health portfolio, including maternal and child health, nutrition, community health interventions, and global health security;

B. Strategic Planning and Budgeting for Program Activities (10%)

- Provide technical and program management advice and coordinate USAID's involvement in preparation of RDMA planning and budget documents with a particular focus on development of operational plans, semi-annual and annual progress reports, and various documents required;
- Perform budget formulation duties involved in the process of preparing detailed analyses and estimates of annual funding needs;

- Coordinate with relevant staff in the development and oversight of automated systems for tracking the principal budgetary processes including Operating Year Budget levels, allowances, obligations, Congressional Notifications, earmarks/directives, and mortgages and modifies those systems throughout the year to track budgetary information;

The U.S. Embassy in Thailand is seeking an individual for the position of Executive Assistant in the U.S. Agency for International Development/Regional Development Mission for Asia (USAID/RDMA), located at Athenee Tower, Wireless Road, Bangkok.

JOB SUMMARY:

This position reports directly to the Supervisory Executive Specialist. The position is a mixed position which includes: a) management of correspondence and records (C&R); b) supervision of one mail clerk and mail operations; c) supervision of two receptionists; and d) Contracting Officer's Representative (COR) for the vehicles/drivers' contract.

As the C&R subject matter expert, the incumbent manages, monitors, and maintains RDMA and client Mission/Offices' files and communications systems inclusive of the responsibility for on-the-job training of secretarial staff and technical office file custodians on USAID official record management procedures and policy. Management of RDMA's mail system includes coordinating the flow of all incoming and outgoing correspondence (including pick-up/delivery and distribution of postal mail, courier mail, faxes, and unclassified cables), maintenance and disposal of official USAID Mission files, submission of annual file and disposition plans, and maintenance of vital records. Reception responsibilities include supervising and scheduling coverage of the reception desk, managing the telephone system, and oversight of telephone bills to ensure proper usage and payments. As the COR for the contract that provides RDMA vehicle and driver service, the incumbent reviews requests for transportation and schedules two drivers in accordance with regulations and policy, conducts performance monitoring for quality control, liaises with the contractor for driver availability outside normal work hours, reconciles bills with usage, and prepares and manages the submission of vehicle records.

MAJOR RESPONSIBILITIES:

Correspondences & Records (C&R): 50%

Record Management

- Serves as the Mission's subject matter expert on correspondence and records management, advising staff of requirements, advising the EXO on issues, and ensuring compliance with regulations and policies.
- Plans, administers and submits Mission's file plan, manages the vital records program, and serves as the regional expert for client Mission/Offices' submission.
- Provides briefing for the Mission's newcomers and file custodians, periodic classroom training to all USAID/RDMA staff and all client Mission/Offices' staff on the USAID Record Management filing system including the Annual file plan and vital record report. This includes training on proper classification and labeling; maintenance and filing of program, case and subject files; and procedures for archiving, storage, destruction and/or shipment of records to Washington for storage.
- Monitors and performs periodical audits to ensure that Mission's records management system is in accordance with the USG policies, rules and regulations. Works with file custodian to correct deficiencies; provides advice on office file structure.
- Conducts a records' self-evaluation annually in conjunction with the Federal Manager's Financial Integrity Act (FMFIA).
- Manages and maintains the Mission's auxiliary file storage space including proper marking, storage, shipping to U.S. storage as appropriate, and disposal.
- Manages responses to Freedom of Information Act (FOIA) requests for information, researches files and provides assistance to Mission staff.
- As the Mission expert on records and file management, the incumbent is expected to keep current on new technology related to records, files and communication systems (including Documentum and other electronic filing systems); and provide written and oral directives necessary for adopting USAID C&R management policies and procedures.
- Ensures vital records are updated at appropriate intervals in relation to the purpose they serve. Submits vital record reports to USAID/W as mandated.

Mail, Cable, and Facsimile:

- Supervises one Mail Clerk.
- Retrieves unclassified cables for the Mission and distributes to appropriate personnel or office. Draft or review for correct format outgoing cables and timely transmit through the Clout system.
- Working with Embassy Bangkok Information Technology (IT) staff coordinates postal and courier mail delivery, and coordinates cable searches, comeback copies, and retrieval to resolve technical problems.
- Liaises with Department of State Army Post Office (APO); supervises the processing all incoming and outgoing mail including postal, special courier, diplomatic pouch and APO.
- Reviews and verifies all billings for pouch and courier services; tracks packages for customer.
- Provides reproduction services, including printing of materials, binding and laminating of mission publication such as temporary business cards, quick emergency directory cards and warden cards, and bomb threat report signs.

Transportation Management: 30%

- Performs the duties of Contracting Officer's Representative for the Vehicle/Driver Contract.
- Manages the Mission's 'motor pool' by scheduling and tracking according to Mission's needs.
- Distributes and prioritizes the daily work of drivers.

- Reviews and certifies monthly driver timesheet including fuel, Overtime and expressway expense, and ensures that proper authorizations are in place for each and every transportation action.
- Prepares relevant reports on all motor pool activities.

Supervision of Receptionists and Telephone Management: 20%

- Supervises two Receptionists.
- Programs telephone system; trains staff on telephone features.
- Oversees and maintains Emergency phone listings; warden tree and Regional Security Office contact database.
- Updates Short Message Service (SMS) database for emergency dissemination of text messages.
- Oversees the distribution and payment of home telephone bills.
- Provides coverage as a receptionist in the absence of both receptionists.

QUALIFICATIONS REQUIRED AND SELECTION CRITERIA:

All applications must address each selection criterion detailed below with specific and comprehensive information supporting each item in DS-174 block no. 19-22. If the application submitted fails to demonstrate eligibility, the application will be marked unqualified. It is the responsibility of the applicant to provide all pertinent information.

- (1) **Education:** College or university study (at least two years of full time post-secondary study) in the field of secretarial, commercial, information system, computer, or other major in social sciences or arts is required.
- (2) **Experience (30 points):** A minimum of three years of experience in general office administration with some specific experience in the area of files management and maintenance, supervision of drivers, or receptionist operation is required.
- (3) **Language:** Level IV (fluent) English and Thai, in speaking, listening and writing, is required.
- (4) **Knowledge (30 points):** Knowledge of general office operation with a focus on records management and maintenance, regulations and policies on correspondence control and file management including vital records and records disposal, and knowledge of (a) records maintained by the Mission and the system by which these records are kept; (b) the organization, functions, personnel, and practices of the activities to which service is provided; and (c) knowledge of mail systems, including Pouch, and vehicle operation and usage regulations is required.
- (5) **Skills and Abilities (40 points):**
 - Must have administrative and managerial abilities to organize and manage the mixed functions of Correspondence and Records, drivers, and receptionists.
 - Must have the ability to analyze existing systems and procedures and recommend improvements to enhance efficiency.
 - Must be able to explain procedures and requirements tactfully to Mission personnel and to train File Custodians and team leaders in the establishment, maintenance and disposition of decentralized, project and working files.

- Must be detail oriented and accurate.
- Must have excellent computer skills in word, excel, and access, and ability to learn new programs.
- Must be able to analyze large amounts of data such vehicle logs, gasoline usage, driver hours, and telephone bills to ensure proper usage and payments.
- Must be able to communicate effectively in writing and orally.

SELECTION PROCESS:

Applications will be initially screened and scored for eligibility in accordance with the required qualifications and points mentioned above. To be considered for candidacy, applicants must address each criterion in their application as to how they meet the minimum qualifications for this position. Top-ranked candidates who meet the minimum qualification will be given a recruitment test. The recruitment test and interview will be structured around the selection criteria above. Applicants with passing marks from recruitment test and with a valid TOEIC score of 855 or above will be invited for an interview. Recruitment test and interview will be conducted in USAID/RDMA Bangkok, Thailand. USAID/RDMA will screen for nepotism/conflict of interest in determining successful candidacy. Reference checks will be conducted once the applicant pool is narrowed down to the top candidate(s). Only shortlisted candidates for final interview will be notified of the selection result. Internal candidates must have successfully completed a one year probationary period of employment before being eligible to apply.
