1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform trash removal and proper disposal, including furnishing all labor, material, equipment and services, for the Embassy of the United States of America, Banjul. The price listed below shall include all labor, materials, personal protective equipment, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for standard services and any temporary additional services that have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

Because Temporary/Additional Services are based on indefinite delivery/indefinite quantity the minimum and maximum amounts are defined below:

Minimum: The Government shall place orders totaling a minimum of D45,000.00. This reflects the contract minimum for the base year and each option period.

Maximum: The amount of all orders shall not exceed D225,000.00. This reflects the contract maximum for the base year and each option period for temporary/additional services.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with *four option years*. The initial period of performance includes any transition period authorized under the contract.

1.1 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT), if applicable to this contract, shall be separately identified in the quote and invoices. VAT amount should be charges as a separate line on the proposal and on all invoices.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. SCOPE OF WORK

The purpose of this fixed price contract is to obtain trash and gardening waste collection, and disposal for real property owned or managed by the U.S. Government The Gambia. The Contractor shall perform waste disposal services in all designated offices and residences. The contract will be for a one year period from the date of the contract award, with four option years

The Contractor shall furnish all managerial, administrative, and direct labor personnel, personal protective equipment, trucks and tools that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

1.1 GENERAL INSTRUCTIONS

The Contractor shall prepare general instructions for the work force to empty bins and dumpster, haul the waste in a closed truck, and dispose of the waste in accordance with the laws of the government of The Gambia. The Contractor shall provide drafts to the Contracting Officer's Representative (COR) for review within ten (10) days after contract award. The COR must approve these general instructions before issuance.

1.2 Duties and Responsibilities:

Contractor shall provide a trash collection vehicle/truck and shall be in good working condition

Trash truck shall be suitable for the task, i.e. rear loaded and enclosed or covered with a tarp to avoid littering along the road

Contractor shall provide fuel and labor needed to accomplish this task

Contractor shall provide the approved safety gear for their workers such as, nose/face mask, eye shield, safety boots, gloves, coveralls, etc.

Due to security and safety requirements, a dedicated truck shall be assigned to serve all properties. The Contractor shall provide the original copy of the police character reference for each employee to serve the U.S. Embassy offices and residences. Details of the vehicle(s) such as description, plate number, driver's name, and workers name shall be provided by Contractor prior to the due date of start of the contract to facilitate access to all locations. Any change in the vehicle or work force shall be communicated at least three (3) working days in advance to allow for proper screening to be done

Contractors workers are prohibited from riding at the back of the trash truck on the highway as this is not only unsafe but considered a health hazard to the workers

Violation of any of the safety guidelines stated above may constitute a violation of the contract and could lead to termination of the agreement and any impending damages shall be solely borne by contractor.

- 1.2.1 Certain areas listed in paragraph #3 require an escort and can only be entered during scheduled times. The General Instructions shall emphasize security requirements so that accidental security violations do not occur.
- 1.2.2. Contractor shall schedule routine trash collection requirements to ensure that these are done in the order and time frame that are most efficient and have the least impact on normal operations. They are to be performed
 - **Twice weekly:** Chancery, Kairaba Avenue; Warehouse, Kanifing; and Ambassador's residence, Atlantic Avenue, Fajara.
 - **Once weekly:** all other locations.
- 1.2.3. Contractor shall schedule periodic trash collection requirements so that it causes minimal disruption to the normal operation of the facility. The COR shall determine the schedules presented which meet the needs of the individual facility.
- 1.2.4. Temporary Additional Services are services that are defined as Standard Services but are required other than the normal collection. These services shall support special events or separate requirements. The Contractor shall provide these services in addition to the scheduled services specified in this contract. The COR will request a quotation for these additional services, to be ordered on an as-needed basis. The Contractor shall provide a quotation for each requested additional service, and shall take action only after written confirmation by the Contracting Officer or COR. This work shall be performed by Contractor trained employees, and shall not be subcontracted. The COR may require the Contractor to provide temporary additional services with 24 hour advance notice.
- 1.2.5 The Contractor shall include in its next regular invoice details of the temporary additional services and, if applicable, materials, provided and requested under temporary additional services. The Contractor shall also include a copy of the COR's written confirmation for the temporary additional services.

2.0 MANAGEMENT AND SUPERVISION

- 2.1 The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff.
- 2.2 The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.
- 2.3 The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

3.0 LOCATION OF RESIDENCES AND OFFICES

4.0 PERSONNEL

4.1 General. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

4.2 Standard of Conduct.

4.2.2 Uniforms and Personal Equipment. The Contractor's employees shall **wear uniforms, and personal protective equipment (PPE) to include gloves, masks and proper shoes** approved by the COR. In addition Contractor employees shall use appropriate tools such as a shovel when emptying a dumpster.

4.2.3 Neglect of duties shall not be condoned. The Contractor shall enforce unreasonable delays or failures to carry out assigned tasks, and cooperate in upholding the integrity of the worksite security.

4.2.4 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

4.2.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

4.2.6. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- unauthorized use of Government property, theft, vandalism, or immoral conduct;
- unethical or improper use of official authority or credentials;
- security violations.

4.2.7 RESERVED

4.3. Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

4.4. Personnel Security

- 4.4.1 After award of the contract, the Contractor shall provide an original copy of the Police certificate, and the following list of data on each employee and supervisor assigned to this contract: name as appears on Gambian government identification card or driver license, and identification card number.

5.0. MATERIALS AND EQUIPMENT

The Contractor shall provide all necessary equipment, supplies, tools and PPE to perform the work identified in this contract. **The truck shall be closed or tightly covered by a tarp to avoid littering in the streets.**

6.0 RESERVED.

7.0 INSURANCE

- 7.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

D450,000.00 : Personal Injury and General Liability shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

- 7.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)
- 7.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.
- 7.4 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:
- a) any property of the Contractor,
 - b) its officers,
 - c) agents,
 - d) servants,
 - e) employees, or
 - f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

- 7.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to or from the site.
- 7.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.
- 7.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

8.0. LAWS AND REGULATIONS

- 8.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. Trash and waste disposal shall be retrieved and delivered to the appropriate disposal facility in accordance with the regulations and laws of the government of The Gambia. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.
- 8.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

11. **QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

11.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

11.2 STANDARD. The performance standard is that the Government receives no more than two (2) customer complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions- Commercial Items), if any of the services exceed the standard.

11.3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

(1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,

(2) Discriminating in the award of subcontracts on the basis of religion.
