ATTACHMENT A
PERFORMANCE WORK STATEMENT (PWS)

1.0 SCOPE OF WORK

The American Embassy in Banjul requires the services of a qualified contractor to maintain the swimming pool at Chief of Mission Residence and Deputy Chief of Mission Residence. Any proposed changes to this statement of work shall be approved in advance by the U.S. Government's Contracting Officer.

2.0 PERSONNEL

The contractor shall furnish sufficient personnel with the technical knowledge and experience necessary to safely complete the work.

3.0 U.S. GOVERNMENT-PROVIDED MATERIAL

The U.S. Government will provide materials for this contract. Basic electricity service for hand tools and water source will be provided on site.

4.0 CONTRACTOR-PROVIDED MATERIAL

The Contractor shall provide all pool chemical treatment supplies for this contract.

5.0 SPECIFIC OBJECTIVE AND ASSOCIATED TASKS

5.0.1 The specific objective agreement of this Agreement shall be to maintain the swimming pool at the Chief of Mission Residence and Deputy Chief of Mission Residence in a safe and acceptable level for the daily use of the occupants and their guests.

5.0.2 Below are listed the minimum tasks that shall be performed by the vendor for a period of one year, with the coordination and cooperation of the Facilities and Maintenance office and the occupants of the residences at Chief of Mission Residence and Deputy Chief of Mission Residence.

5.0.3 The US government shall provide to the contractor a list of best maintenance practices to keep the swimming pool and its water safe, the premises, and a schedule of frequency for works to be carried out.

5.0.4 Any impediments to safe use or function of the swimming pool must be reported to the Facilities and maintenance office/ house manager immediately upon discovery.

5.1 POOL WATER – MINIMUM REQUIREMENTS

5.1.1 Check and maintain water level.

5.1.2 Check pumps, and report deficiencies to the Facilities and Maintenance office immediately.

5.1.3 Check water clarity and adjust chemical or clean as required to maintain clear water at acceptable chemical levels.

5.1.4 Clean pump's filters, and sand filters. Report any deficiencies to the Facilities and Maintenance (FM) office immediately.

5.1.5 Check pool drains and keep free of debris.

5.1.6 Clean hair filter strainer, skimmer basket and overflow trough.

5.1.7 Clean pool water of floating debris.

5.2 GENERAL MAINTENANCE – MINIMUM REQUIREMENTS

5.2.1 Clean and scrub deck.

5.2.2 Clean pool bottom and side walls.

5.2.3 Remove obstructions and debris from deck.

5.2.4 Check pool lights and area lights. Report deficiencies to the FM office immediately.

5.2.5 Check pool area air quality and environment (humidity, insects, mold, rodents, etc.) Enter any findings in logbook and report findings to FM office immediately.

5.2.6 Verify that all lifesaving equipment is in its designated place. Report any missing or broken equipment to the COR immediately.

5.2.7 Prepare pool for wet and dry seasons.

5.3 CHEMICALS

5.3.1 Store all chemicals in a well-ventilated, cool, dry location away from mechanical equipment and volatile materials such as paint, gasoline, kerosene and oil.

5.3.2 Ensure that personnel who maintain pools are properly trained in the safe handling, use, and storage of all swimming pool chemicals according to the manufacturer's instructions and that the appropriate personal safety equipment is used when handling these chemicals and follow the chemical label directions.

5.4 SAFETY REQUIREMENTS

5.4.1 All tools, materials, and equipment shall be provided by the US government and must meet all US government safety requirements.

5.4.2 All work shall be performed in accordance with US government safety standards and recognized safe practices.

5.5 SECURITY REQUIREMENTS

5.5.1 All contract workers must be under the constant supervision of an embassy employee while on U.S. Government property.

5.5.2 All workers are subject to a security background check, and must be

5.5.3 Approved or cleared by Embassy Security Officer prior to entering Embassy property. Standard security procedures already in place must be followed for access by contract workers.

5.5.4 All security requirements mentioned above are subject to approval and/or modification by the Embassy Security Officer.

6.0 QUALITY ASSURANCE PLAN (QAP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

6.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

6.2 STANDARD The performance standard is that the Government receives no more than two (2) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

6.3 PROCEDURES

6.3.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

6.3.2 The COR will complete appropriate documentation to record the complaint.

6.3.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

6.3.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

6.3.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

6.3.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

6.3.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

6.3.8 Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
