SECTION 1 - THE SCHEDULE

SCHEDULE OF SUPPLIES/SERVICES / PRICES (Block 20 / Block 23) DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1.0 GENERAL

The purpose of this procurement is to expediently obtain and install critical power equipment, in order to support the offices of the United States Agency for International Development (USAID) in Farol, Dili, Timor - Leste. The Contractor's proposal shall include an estimated delivery date, and bar chart to identify the complete project schedule, to include installation and commissioning. The proposal shall include the cost of transportation and delivery to the *USAID Office, Farol, Dili*.

1.1. DESCRIPTION

1.1.1 Supply and install an FG Wilson Generating Set Model P88-1, 380-415 volts, 50 Hz, Prime Rated @ 80 KVA. This will replace the existing FG Wilson generator unit. The unit shall be manufactured complete with system controls and all necessary accessories to make the genset fully operational. All equipment shall be as specified but shall not be limited to the items specified herein.

1.1.2 Prime and overload ratings shall meet requirements herein.

1.2. REQUIREMENTS

1.2.1 The electric generating system consists of a prime mover, generator, electronic governor, couplings, and all controls, tested as a complete unit.

1.2.2 Conform to N.E.C. and applicable inspection authorities.

2.0 ENGINE-GENERATOR SET

2.1.1 An FG Wilson automatic battery charger mounted inside the genset enclosure, in its own cabinet, shall be provided.

2.1.2 A heavy duty, lead acid battery set shall be provided by the generator set manufacturer of adequate voltage and amperage capacity to start and operate the engine. Provide all intercell and connecting battery cables as required for complete installation. The battery shall be shipped in place fully charged with electrolyte.

2.2 The genset, parts shall be warranted by the offeror in accordance with the terms of this contract.

3.0 DELIVERY, INSTALLATION, TESTING AND COMMISSIONING

The Contractor shall complete delivery, installation, testing and commissioning in accordance with the Scope of Work (Attachment to this solicitation STT10014Q0011).

4.0 MISCELLANEOUS

4.1 FACTORY TESTING

4.1.1 Before shipment of the equipment, the engine-generator set shall be tested under rated load and power factor for performance and proper fronting of control and interfacing circuits. Tests shall include:

4.1.1.1 Verifying all safety shutdowns and components are functioning properly.

4.1.1.2 Single step load pick-up per NFPA 110-1985, Paragraph 5-13.2.6.

4.1.1.3 Transient and voltage dip responses and steady state voltage and speed (frequency) checks.

4.1.1.4 The factory test data sheet shall identify all tests (PASSED or FAILED) and accompany each generator set. This will be reviewed by the DOSREP before written acceptance is provided.

4.2 OWNERS MANUALS

4.2.1 Two (2) sets of owner's manuals specific to the genset and products supplied shall be located inside each unit and accompany the equipment. General operating instructions, preventive maintenance, wiring diagrams, schematics and parts exploded views specific to this model shall be included. A PDF version of the owner's manuals shall also be provided on a compact disc and shipped with each generator.

4.3 SUBMITTALS

4.3.1 Provide two complete sets (for each rating of machine) of Engineering Submittal for approval, prior to production release, showing all components, in addition to the engine, generator and automatic transfer switch. Submittals shall include complete system interconnection wiring diagrams and manufacturer's warranty form indicating compliance with these specifications.

The following spare parts shall be provided: Pre-programmed control panel(01 unit), fuel filters(10 ea), fan belt (02 ea), and air filters(10 ea).

4.4 FIELD SERVICES

4.4.1 Disconnect, remove from site and deliver the existing old/rear generator from USAID Office to the embassy warehouse in Bebonuk

4.4.2 Disconnect, relocate and reconnect the existing front generator to the rear pad

4.4.3 In accordance to the manufacturer’s recommendation, install, connect, test and commission the new generator to the front pad.

4.5 WARRANTY

The offeror shall provide a one-year warranty on parts, which starts from the date the equipment is commissioned on-site. This requirement shall not modify or change the standard contract warranty agreement.

5.0 GOVERNMENT ACCEPTANCE

The generator set and spare parts are being imported duty free under the diplomatic duty free status of the U.S. Embassy. The goods and services will be considered delivered once received, installed, inspected, tested and commissioned at the USAID offices, Dili.

6.0 Table II - ITEM PRICING [QUOTER/OFFEROR COMPLETES]

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

7.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
