#### I. Scope of Services

The Contractor shall provide and deliver high grade fuel to the U.S. Embassy Lome and Peace Corps Togo, as described below:

- Delivery of gasoline and/or diesel fuel to the U.S. Embassy and Peace Corps on site fuel storage tanks.
- Deliver diesel fuel to U.S. Embassy Residences generator diesel fuel tanks and the fuel tanks for the generators at Peace Corps compound.
- Provide an in-house service that will submit exoneration documents to the government for both the U.S. Embassy and Peace Corps that will meet and satisfy government regulations.
- Provide fuel prices without taxes and without charging taxes to the U.S. Embassy and Peace Corps.
- Provide regularly scheduled deliveries that meet all safety regulations and requirements for the U.S. Embassy, Peace Corps and the successful local bidder.
- Provide a billing system that is timely and follows the U.S. Embassy and Peace Corps requirements.
- Provide a fuel delivery tracking system that allows the U.S. Embassy, Peace Corps and the successful local bidder to track fuel deliveries accurately.
- Provide a fuel card system that will allow both the U.S. Embassy and Peace Corps operations to purchase fuel inside of Lome, Togo, and throughout the Togolese country side.
- Provide a fuel pump system to Peace Corps that will dispense fuel from the Peace Corp fuel tank located at the Peace Corps office.

The contract type will be a fixed price with economic price adjustment indefinite quantity/indefinite delivery under which may be placed firm fixed-price delivery orders.

The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, and transportation necessary to supply and deliver gasoline and/or diesel fuel to the U.S. Embassy Lome and Peace Corps.

In consideration of satisfactory performance of all scheduled services required under this contract, the Contractor shall be paid a firm fixed-price for each delivery. The Contractor shall

be compensated monthly upon receipt of a proper invoice for all deliveries made under delivery orders during the month.

**I. Scope of Work**

For each year of the contract, the U.S. Government guarantees a minimum order of 1,000 liters of gasoline and/or diesel. The maximum amount of fuel ordered under each year of the contract shall not exceed 120,000 liters.

The Contracting Officer may issue oral orders that will be confirmed in writing.

The fuel provided will be gasoline and/or diesel. For supply and delivery of the fuel, the Contractor shall be paid the fixed price per unit as listed above. This price is not to exceed any official rate, as set by laws enacted by the government of Togo.

**Delivery:**

The Contractor shall deliver fuel to the U.S. Embassy Lome and Peace Corps Togo. Delivery must be made between the hours of 8:00 to 16:00 from Monday to Thursday. The Contractor shall promptly deliver the oil by tanker truck on the date and time that are specified on delivery orders issued under the contract. Any contractor personnel involved with the delivery of the oil shall comply with Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. The driver of the tanker truck must submit an invoice to the COR for approval at the time any delivery is made.

All fuel delivery trucks must have GPS or other comparable track devices installed on the vehicle and maintaining in good working order.

All fuel delivery trucks must be connected to a vehicle tracking system program (GPS or comparable tracking system) that allows the vehicle to be tracked from point of fuel origin to each delivery location ( U.S. Embassy, Peace Corps fuel delivery locations and U.S. Embassy residential housing generator fuel tanks). State below what type of tracking system your company uses.

The fuel delivery company must provide the U.S. Embassy and Peace Corps with the fuel delivery tracking report upon request from either / or both the U.S. Embassy and Peace Corps in order to verify fuel deliveries.

It is the responsibility of the fuel supply vendor and fuel delivery truck company to insure that the fuel ordered by the U.S. Embassy and Peace Corps arrive from the point of origin to the fuel delivery sites safely and with the correct amount fuel in the fuel delivery truck.

The U.S. Embassy and Peace Corps accepts no responsibility for any damage en-route from fuel origin location to fuel delivery sites to the fuel delivery vehicle and /or the fuel inside of the fuel delivery truck's transportation tank located on the delivery truck.

When fuel delivery trucks arrive at delivery site they must be equipped with devices that measure the fuel level in the truck's holding tanks.

Fuel delivery trucks must have hoses that will connect from the delivery truck up to the U.S. Embassy's and Peace Corps fuel storage tanks located on each property, and at each U.S. Embassy residential housing property location. These hoses must be free of damage to the hoses themselves and to the hose connection. The truck must be equipped with a proper grounding cable with a clamp.

All fuel delivery trucks must be furnished with a safe, good working condition pump that will move the fuel from the fuel delivery truck to the U.S. Embassy, Peace Corps fuel tank locations and at each U.S. Embassy residential housing property location.

Damaged hoses will not be allowed to dispense fuel from the fuel delivery trucks to either the U.S. Embassy, Peace Corps fuel tanks and at each U.S. Embassy residential housing property location.

If fuel deliver trucks arrive at either the U.S. Embassy or Peace Corps fuel delivery sites with damaged hoses, condensation in the fuel delivery tanks, water inside of fuel tanks, or any other issue that compromises' the safe integrity of the fuel or the safety of U.S. Embassy and Peace Corps personnel that assist in the delivery of the fuel to the U.S. Embassy, Peace Corps fuel storage tanks and at each U.S. Embassy residential housing property location ; the U.S. Embassy and Peace Corps will refuse delivery and the trucks will have to return to the company's fuel delivery origin point and send another fuel delivery truck that meets all fuel safety delivery requirements.

This includes any safety issues with the fuel delivery truck themselves and or any unsafe practices of the fuel company's technicians that operate the fuel delivery truck and fuel delivery equipment.

If the U.S. Embassy or Peace Corps refuses delivery and the fuel delivery truck must return to fuel delivery point of origin to acquire acceptable fuel hoses, the delivery cost will be fortified, and no charges for delivery will be accepted either for the original or second trip to deliver fuel.

The fuel delivery trucks must be of a type and quality that fuel can be safely transported from the fuel origin location to the U.S. Embassy and Peace Corps fuel tanks and at each U.S. Embassy residential housing property location. This includes but not limited to fuel storage tanks that do not leak fuel; allow condensation or other types of moisture to enter the fuel cells on the truck.

The fuel delivery truck's fuel tanks must be free of contamination and able to prevent fuel from becoming contaminated from elements such as water and condensation inside of the fuel storage cells.

Provide below a detailed description of the size, type and make of the vehicles you would use to deliver fuel to the U.S. Embassy, Peace Corps fuel storage tanks and at each U.S. Embassy residential housing property location.

Residential & Embassy Diesel Fuel deliveries for generator fuel tanks:

The U.S. Embassy requires diesel fuel delivered for their generator fuel tanks located at all Embassy residences and at the U.S. Embassy Compound.

The Peace Corps requires diesel fuel delivered for their generator fuel tanks located at the Peace Corps Compound.

The deliveries for the U.S. Embassy residential housing would be ordered as an on-call request to all residences in the U.S. Embassy housing pool.

The deliveries for the Peace Corps Compound would be ordered as an on-call request as needed.

U.S. Embassy - Peace Corps fuel delivery areas:

Diesel fuel for the Embassy residences will be delivered to the following zones in Lome, Togo:

- Résidence La Caisse
- Hôpital
- Palais des Congrès area

The U.S. Embassy reserves the right to add or subtract Embassy housing from the delivery list.

Peace Corps reserves the right to set up infrequent deliveries to the residences as the need arises. They will provide details when scheduling for deliveries.

Fuel delivery schedule:

Fuel must be delivered quarterly to both the U.S. Embassy and Peace Corps. Both the U.S. Embassy and Peace Corps have the right to decide the dates for fuel deliveries.

The U.S. Embassy and Peace Corps reserve the right to add or subtract to the quarterly order delivery fuel schedule for their specific delivery locations without affecting the contracted price for the time period the contract is in place.

Fuel pump for Peace Corps fuel tank:

The Peace Corps requires the vendor to furnish, install and maintain a fuel pump system that will dispense fuel from the Peace Corps fuel tank located at the Peace Corps office. This fuel pump will be returned to the vendor upon termination of the fuel delivery contract.

During the fuel contract period, the fuel pump furnished by the vendor must be replaced by the vendor if the existing fuel pump ceases to function to deliver fuel to Peace Corps vehicles.

Fuel Cards:

Bidders must provide fuel cards that can be used inside of the city limits of Lome, Togo as well as throughout the country of Togo.

Bidders must have fueling stations located throughout the country and especially in Kpalime, Atakpame, Sokode, Kara and Dapaong. Fuel card system should also work in Accra, Ghana.

The fuel card system is for fueling vehicles only. No other products or services shall be purchased with the card. The fuel card system shall be able to be used for both gasoline and diesel fuel vehicles.

All bidders need to provide a fuel card system that will facilitate the purchase of fuel. The fuel card system must allow the U.S. Embassy and Peace Corps to have their employees assigned pin numbers specific to each employee.

The fuel card system must allow for the assignment of only one fuel card per vehicle. The fuel card system must use a billing system that is easy to use and understand.

The fuel card billing system must allow both the U.S. Embassy and Peace Corps the ability to receive separate billings for each office within itself. There are offices that require separate internal billing on the part of the U.S. Embassy and Peace Corps. Bidders must work with both the U.S. Embassy and Peace Corps to set-up this internal process for each operation. The fuel card billing system must be based upon a monthly billing system.

Please describe in detail below your fuel card system and any services and features we would receive at no additional charge outside of the contract price.

Fuel card documentation / billing:

Billing system must allow for a monthly thirty (30) day billing and invoice system that can be used for internal charges for the individual sections inside of the U.S. Embassy and Peace Corps.

In addition to the monthly thirty (30) day billing cycle from the use of the fuel card, the information should be able to provide in detail, identity of the person fueling the vehicle, make and model of vehicle, time and date of fueling, and location of fuel station used. All billing must be sent electronically via e-mail to the U.S. Embassy.

Both the U.S. Embassy and Peace Corps reserve the right to ask for bidders to furnish invoice within or outside of the thirty (30) day billing cycle. Bidders must provide separate billing for the U.S. Embassy and Peace Corps.

Price Adjustment:

- (a) The unit price per liter of gasoline and/or diesel may be adjusted based on increases or decreases in the official price of fuel, mandated by the government of Togo.
- (b) To request an adjustment in price, the Contractor must provide written notification of the price change to the Contracting Officer at least one week before the new price is to be effective. This notification must be accompanied by a copy of the official announcement of the price change, showing the new price and its effective date. The officer or general partner of the Contractor having overall responsibility for the Contractor's affairs shall certify the submission by written signature.
- (c) The U.S. Government will make no adjustment to the contract price that relates to any wages, overhead, fixed costs, general and administrative expenses, materials, or profit. Only the amount which is a direct result of an increase or decrease in the price of fuel to be delivered under this contract shall be considered by the U.S. Government as the basis for contract price adjustments.
- (d) The Contractor may not request an adjustment under this clause after final payment has been made under this contract.
- (e) This clause shall only apply to laws enacted by the government of Togo which meet the criteria set forth above. The U.S. Government will make no adjustments in contract price due to currency devaluations or fluctuations in exchange rates.
- (f) **QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person;

(4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person

which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

(b) Under Section 8(a), the following types of activities are not forbidden "compliance with the boycott," and are therefore exempted from Section 8(a)'s prohibitions listed in paragraphs (a)(1)-(6) above:

(1) Complying or agreeing to comply with requirements:

(ii) Prohibiting the shipment of goods to Israel on a carrier of Israel, or by a route other than that prescribed by the boycotting country or the recipient of the shipment;

(2) Complying or agreeing to comply with import and shipping document requirements with respect to the country of origin, the name of the carrier and route of shipment, the name of the supplier of the shipment or the name of the provider of other services, except that no information knowingly furnished or conveyed in response to such requirements may be stated in negative, blacklisting, or similar exclusionary terms, other than with respect to carriers or route of shipments as may be permitted by such regulations in order to comply with precautionary requirements protecting against war risks and confiscation;

(3) Complying or agreeing to comply in the normal course of business with the unilateral and specific selection by a boycotting country, or national or resident thereof, of carriers, insurance, suppliers of services to be performed within the boycotting country or specific goods which, in the normal course of business, are identifiable by source when imported into the boycotting country;

(4) Complying or agreeing to comply with the export requirements of the boycotting country relating to shipments or transshipments of exports to Israel, to any business concern of or organized under the laws of Israel, or to any national or resident of Israel;

(5) Compliance by an individual or agreement by an individual to comply with the immigration or passport requirements of any country with respect to such individual or

any member of such individual's family or with requests for information regarding requirements of employment of such individual within the boycotting country; and,

(6) Compliance by a U.S. person resident in a foreign country or agreement by such person to comply with the laws of that country with respect to his or her activities exclusively therein, and such regulations may contain exceptions for such resident complying with the laws or regulations of that foreign country governing imports into such country of trademarked, trade named, or similarly specifically identifiable products, or components of products for his or her own use, including the performance of contractual services within that country, as may be defined by such regulations.
