DESCRIPTION/SPECIFICATIONS/WORK STATEMENT**

1. GENERAL

The US Embassy Baghdad requires the Contractor to arrange for the printing of 180,000 posters for delivery to the U.S. Embassy and for the broadcasting of two 60 second television commercials on Iraqi TV stations.

2. STATEMENT OF WORK

2.1 PRODUCTION OF POSTERS

- 2.1.1 The posters shall be printed on A2 size paper, glossy, #80 poster paper, and in full 4/0 color on one side.
- 2.1.2 There will be 18 different designs of the posters to be printed, and each design shall be printed in 10,000 copies for a total of 180,000 posters.
- 2.1.3 The Embassy shall provide designs to contractor immediately upon contract award.
- 2.1.4 Contractor will produce 5 samples of each poster design within three days of receipt of designs to ascertain that finished products are of superior quality.
- 2.1.5 The Embassy shall have three working days to review and approve the samples.
- 2.1.6 The contractor will produce the remaining posters no later than 10 business days after sample approval.

2.2 TV COMMERCIALS DISTRIBUTION AND BROADCASTING

- 2.2.1 The Embassy shall provide two TV commercials, each 60 seconds long, in the format required by the TV stations.
- 2.2.2 The Contractor shall arrange for their broadcasting by three Iraqi mid-tier TV stations during prime time on regular workdays, Sunday through Thursday between 2000 and 2200 in accordance with the broadcasting schedule and approved by the Contracting Officer's Representative (COR).
- 2.2.3 Each commercial shall be broadcast once a day on each TV station, starting the second Sunday from the date of contract award and continued for three consecutive weeks.

4. DELIVERY LOCATION AND TIME

- 4.1 The contractor shall deliver the posters to the following address:

- 4.2 .Any contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice of at least 5 calendar days will be required.
- 4.4 For deliveries to the U.S. Embassy, delivery shall be made between the hours of 10:00 and 15:00, Sunday through Thursday.

5. COPYRIGHTS

- 5.1 The approved products which are the subject of this contract become the sole property of the United States Government for any purpose. The Contractor shall not retain any interests or rights, except for the purpose of publication and duplication of the products stated in this contract.
- 5.2 The Contractor shall not simplify, adapt, or abridge the originals, nor shall he make additions without authorization from the copyright owner.

- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
