1. Scope of Services –

General Terms And Conditions:

- 1) The contractor shall provide simultaneous interpretation, catering services, sound equipment, conference space, conference materials and reimburse lodging and transportation costs for Workshops to be held at the Judicial Development Institute for the U.S. Embassy Baghdad as .
- 2) This is a firm-fixed price type purchase order. The price listed below shall include all labor, materials, overhead, profit, and transportation necessary to furnish the services to the American Embassy in Baghdad.
- 3) All prices are in U.S. Dollars.

1.2 Formal Simultaneous Translation

The Contractor shall:

- 1.2.1 Interpret from and into English, possibly using the consecutive and the simultaneous technique as required, in structured or unstructured settings, in private or in public, with high level officials on difficult or sensitive assignments, using a wide range of standard and non-standard terminology but specializing in legal and economic terminology, for official or unofficial statements. The Contractor shall perform instant analysis in order to understand correctly the substance of the words and information to be interpreted, including attention to detail and nuances. The Contractor shall adapt to constantly changing circumstances, personalities, and work environments.
- 1.2.3 Display fluent spoken and written English and Arabic, covering a wide range of terminology in many fields, as well as thorough knowledge of the government, history, and culture of the United States and of the cultural differences between the languages. The Contractor shall also possess sufficient specialized knowledge to be able to handle, with personal research and/or topical briefings by the Government, any technical subject of high complexity, and be able to bridge terminology gaps, incongruent methodologies, different measurement systems, and similar disparities.
- 1.2.4 Perform interpreting with clarity, accuracy, and professional, poised delivery. The Contractor shall perform interpreting services with the desired tenor of a public statement or the goals to be reached in a negotiation.
- 1.2.5 Trace, analyze, and define previously unknown concepts and theories, developing equally sophisticated counterparts that have the equivalent meaning and impact in a different cultural environment.
- 1.2.6 Adjust to the demands of diplomatic protocol, protective security requirements, and similar considerations. The Contractor may be required to take on a public relations or mediating

role as part of the interpreting, so as not to jeopardize policies and program objectives and in order to obtain the desired results.

1.2.7 Serve as official note taker, when needed.

1.2.8 Transportation. The Contractor is responsible for transportation to and from all locations and events. Transportation arrangements to venues outside of Baghdad will be made on a case to case basis.

1.2.9. Special Requirements

- a) Permits. Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the prosecution of work under this contract.
- b) Release Of Information. All information furnished to the Contractor and developed by the Contractor in connection with this transaction shall be considered privileged. The Contractor shall make no public announcements, including news or press releases about this Agreement.
- c) Standards Of Conduct. The Contractor shall maintain satisfactory standards of competency, conduct, cleanliness, appearance and integrity. Each Contractor employee is expected to adhere to standards of conduct that reflect credit on themselves and the United States Government. Interpreters must at all times use politeness and courtesy in the course of their duties.

1.3 Catering Services

1.3.1 Morning and Afternoon Breaks. Provide two (2) breaks (A.M. and P.M.) daily; times may vary based on conference agenda.

- a) A.M. Break: To be provided approximately 20 minutes (times to be determined based on agenda): The contractor shall provide coffee, tea, water, fruit juices, and pastries (varied daily) at the venue specified in paragraph 2.1 for number of persons stated in the pricing for each respective conference.
- b) P.M. Break: To be provided approximately 20 minutes (times to be determined based on agenda): The contractor shall provide coffee, tea, water, fruit juices, and pastries (varied daily) at the venue specified in paragraph 1.4 for number of persons stated in the pricing for each respective conference.

1.3.2 Lunch. The contractor shall provide meals and beverages for lunch on three days, to be determined by the agenda, for approximately 35 attendees at the venue specified in paragraph 2.1. All meals and beverages for lunch should be provided buffet style if possible, and must be made available for 90 minutes (exact time each day will depend on the conference agenda. The quotation shall include typical menus offered by the hotel for this type of lunch service, including prices.
