**I. PERFORMANCE WORK STATEMENT**

- A. The purpose of this firm fixed price purchase order is to provide services to conduct consultation and prepare the required documents for the employees of the Government of the United States of America in **Turkey** as required by the Turkish Social Insurance Organization's (TSIO, Social Security Office) and as described in Section C.
- B. The contract will be for a one-year period from the date of the contract award, with **4 (four)** one-year options.

**QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- 1. SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
- 2. STANDARD.** The performance standard is that the Government receives no more than five (5) customer complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
- 3. PROCEDURES.**
- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

**MINIMUM AND MAXIMUM AMOUNTS**

During this contract period, the Government shall place orders totaling a minimum of 650 persons for the base year and all option years. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed 1,100 persons for the base year and all option years. This reflects the contract maximum for this period of performance.

**DOSAR 652.216-71 PRICE ADJUSTMENT (AUG 1999)**

(a) The contract price may be increased or decreased in actual costs of direct service labor which result directly from laws enacted and effective during the term of this contract by the Turkish Government. Direct service labor costs include only the cost of wages and direct benefits (such as social security, health insurance, unemployment compensation insurance) paid to or incurred for the direct benefit of personnel performing services under one of the categories listed in Section 1 of this contract. Price adjustments will include only changes in direct service labor costs incurred in order to comply with the requirements of the law. No adjustment will be made under this clause with respect to labor costs of personnel not performing direct service labor under the categories of Section 1, nor for overhead, profit, general and administrative (G&A) costs, or any other costs whatsoever.

(b) For the contracting officer to consider any request for adjustment, the contractor shall demonstrate in writing:

- (1) That the change in the law occurred during the term of this contract and subsequent to the award date of the contract; and,
- (2) That the change in the law could not have been reasonably anticipated prior to contract award; and,
- (3) How the change in the law directly affects the contractors costs under this contract.

(c) The contractor shall present data that clearly supports any request for adjustment. This data shall be submitted no later than 30 calendar days after the changes in the law have been made public. This data shall include, but not be limited to, the following:

- (1) The calculation of the amount of adjustment requested; and,
- (2) Documentation which identifies and provides the appropriate portions of the text of the particular law from which the request is derived.

(d) In order to establish the change between the requested adjusted rate and the original rate, the contractor shall support the appropriate data and composition of the original rate and the requested adjusted rate. This shall include details regarding specific hourly rates paid to individual employees. For contracts paid in U.S. dollars, the contractors request for price adjustment shall present data reflecting:

- (1) The exchange rate in effect on the date of the contractors proposal that was accepted for the basic contract; and,
- (2) The current exchange rate and its effect on payment of workers in local currency.

The allowable adjustment shall be limited to the extent to which increases in direct service labor costs due to host country law changes are not offset by exchange rate gains.

(e) Only direct cost changes mandated by enacted laws shall be considered for adjustment under this contract. Changes for purposes of maintaining parity of pay between employees at the minimum mandated levels and employees already paid at levels above the newly mandated minimums shall not be considered. Therefore, if the contractor elects to increase payments to employees who are already being paid at or above the mandated amounts, such increased costs shall be borne solely by the contractor and shall not be justification for an increase in the hourly and monthly rates under this contract.

(f) Any request for adjustment shall be presented by signature of an officer or general partner of the contractor having overall responsibility for the conduct of the contractors affairs.

(g) No adjustment shall be made to the contract price that relates to any indirect, overhead, or fixed costs, profit or fee. Only the changes in direct service labor wages (and any benefits based directly on wages) shall be considered by the U.S. Government as basis for contract price changes.

(h) No request by the contractor for an adjustment under this clause shall be allowed if asserted after final payment has been made under this contract.

(i) This clause shall only apply to laws enacted by the Turkish Government meeting the criterion set forth above in paragraph (b). No adjustments shall be made due to currency fluctuations in exchange rates.

### **III. VALUE ADDED TAX**

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20  
DESCRIPTION/SPECIFICATIONS/WORK STATEMENT**

The Government of the United States of America requires services entailed for the Turkish Social Insurance Organization (TSIO) for its locally hired employees in Turkey as further described in this Statement of Work (SOW). The required services will encompass the employer's responsibilities for social security under the Turkish laws. The specific coverage consists of the following:

**1. GENERAL CONDITIONS:**

- 1.1. In accordance with the rules and regulations of the Turkish Government's Social Insurance Organization (TSIO)/ Social Security Office, the Contractor will calculate and prepare the required document(s) for the social security premiums of all the employees of the U.S. Embassy and Consulates in Turkey, as defined under section 4.
- 1.2. Within 10 days of start of employment, HR will inform the Contractor the date when a new employee is employed. Accordingly, the Contractor will conduct all procedures and prepare the documents related to the enrollment of the new employee, submit for FMC's approval and file to TSIO, by the 10<sup>th</sup> of the next month. These documents include but are not limited to monthly declarations and accrual vouchers (with amounts due).
- 1.3. U.S. Embassy will conduct actual TSIO payments for all Mission Turkey employees directly to TSIO.
- 1.4. Minimum ten (10) days prior to ending of employment, HR will inform the Contractor the date when a new employee will no longer be employed. Accordingly, the Contractor will conduct all procedures and prepare the documents related to the de-registration of the departing employee, submit for FMC's approval and file to TSIO, by the 10<sup>th</sup> of the next month.
- 1.5. Within maximum of 10 days of the occurrence of an employee's injury, HR will inform the Contractor the date and specifics of the on-the-job injury. In accordance with Turkish Government reporting requirements, the Contractor will prepare the required report for the injury, submit to HR's approval and submit the approved copy to TSIO, and follow-up on TSIO payments on the process by informing FMC representative on all steps.
- 1.6. HR will inform the Contractor the date(s) of employee leaves such as sickness and other absences such as maternity leave; and the Contractor shall report the same to TSIO and follow-up on TSIO payments. TSIO's employee reimbursements for leaves will be deposited to the Embassy account. Also, related information on this process shall be provided in writing to the FMC representative.
- 1.7. The Contractor will be responsible in informing FMC and HR on all revisions and/or modifications in legislations regarding Social Security and Labor laws in addition to Social Security enrollment process with minimum of 10 days prior to enforcement. When changes related to Social Security and Labor laws are effective, the Contractor will inform FMO and HR related to the laws, regulations, mandates, and announcements stipulated in this contract shall be sent to the U.S. Embassy by email.

**2. CONSULTANCY**

When and if required, the Contractor shall provide consultancy service as follows:

- 2.1. Compliance of personnel layoff procedures, according to legislations and processes to be carried out within the framework of Turkish Labor Law, Turkish Social Security Law and Turkish Tax regulations.
- 2.2. Guidance on the avoidance of double taxation per the joint treaty between the United States and Turkey.
- 2.3. Services concerning settlements related to disputes with the Regional Labor Directorate and Labor Inspection in relation to the Social Security Agency (SGK) and administrative penalty provisions.
- 2.4. Provide on-site consultation support two full work days per month from 9:00 am until 5:00 pm at the U.S. Embassy in Ankara, and two full work days each at the Consulate General in Istanbul and the Consulate in Adana.
- 2.5. Upon the request of the U.S. Embassy, provide services regarding principles and fundamentals of preparing monthly official organization notifications regarding Social Security and Labor legislations, monthly premium and service documents, and resignation notifications.
- 2.6. Assist with TSIO registration of part-time or full-time domestic or foreign staff at the residences of U.S. diplomatic employees. Provide to diplomats the monthly cost of social security insurance premiums and information on how these premiums are paid.

### **3. TERM of ELIGIBILITY and EFFECTIVE DATE**

Under this contract, the U.S. Government has each employee enrolled at least 1 calendar day prior to the start date with the United States Government. An employee is considered active ("on the rolls") whenever such employee is on approved annual or sick leave, whether paid or unpaid. No change of enrollment outside of these time periods shall be valid unless authorized by the U.S. Mission, due to an administrative error, and upon written agreement of the Contracting Officer's Representative and the Contractor.

### **4. ELIGIBLE PARTICIPANTS**

Eligible Employees - The employees eligible for social security services including all current active employees of the United States Government, employed within the geographic boundaries of **Turkey** paid under the Local Compensation Plan, and certified by the Contracting Officer. Covered employees include:

- 4.1 Locally Employed Staff (LES) employed under direct hire appointments, Personal Services Agreements (PSAs), Third country nationals (TCNs) employed under PSAs;
- 4.2 Locally hired U.S. citizens employed under direct hire appointments, PSAs and ORE employees.
- 4.3 Official Residence Employees (ORE), Embassy Recreation Association (ERA) staff, and Marine Security Guard house staff.

### **5. LOCATION OF EMPLOYMENT**

The individuals covered under section 4. must be employed within the geographic boundaries of **Turkey** by Department of State and all U.S. Government agencies operating within the boundaries of Turkey.

## **6. PARTICIPANTS COVERED UNDER a RIDER**

- 6.1 All current active employees of the Chief of Mission, the Deputy Chief of Mission, Consul General in Istanbul and principle offices assigned to their respective official Government residences and paid under an ORE account (see separate rider, Exhibit B). All costs for ORE employees are the responsibility of the employing officer, not the U.S. Government.
- 6.2 OSC personnel are covered under a separate rider.
- 6.3 Employee Recreation Association (ERA) employees are covered under a separate rider.

(2) Refusing, or requiring any U.S. person to refuse to employ or otherwise discriminating against any person on the basis of race, religion, sex, or national origin of that person or of any owner, officer, director, or employee of such person;

(3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person; (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
