**1. Price and Payment:**

1.1 The Contractor shall provide English language training for a maximum of one base year and four option year periods for attendees who have had limited or no English language training as set forth in the Performance of Work Statement. The contractor will provide instruction for up to four levels of proficiency. The courses will be offered twice a week for each proficiency level; each class will last three hours (with a 10 minute break every hour) and will be held twice a week, for an anticipated total of 24 hours per week (total subject to change based upon the final number of proficiency classes).

The price below shall include all service, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the contractor the fixed price per month for standard services that has been satisfactorily performed after receiving an adequate invoice.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from the start date listed in the Notice to Proceed unless the Contractor agrees to an earlier date) on which the performance shall start.

The performance period for this contract is from the start date in the Notice to Proceed and continuing for 12 months, with 4 one-year options to renew at the U.S. Government's (USG) own discretion. The initial period of performance includes a transition period authorized under the contract.

**1.2 Payment**

### 1.3 Definitions

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

### A. PERFORMANCE WORK STATEMENT

1. The Contractor shall provide adult students with English language instruction that focuses on grammar, general interest and conversational skills typically found in a U.S. Embassy environment. The Contractor will work with U.S. Embassy Ankara Human Resources Assistant to develop instruction material and determine proficiency levels of participants. Language instruction will typically include development of speaking, listening, and reading skills in English at various levels. English language training will also focus on job related language terminology and usage in the designated field of interest. There may be need for several instructors who can teach various levels of English on site at Embassy Ankara. These classes should be after work hours, beginning at 18:00 and ending at 21:00 (for a total of three hours with a 10 minute break each hour) and consist of no more than 20 students per class.

Participants shall be measured on their language proficiency levels prior to the commencement of training, at various intervals during the training, and at the end of the course. At the completion of the course, the Contractor shall give certificates to each student that clearly states their level of English ability.

### 2. PERIOD OF PERFORMANCE

The performance period will be determined within the Purchase Order attached to this document.

- a) The contractor will be notified of any cancellation of a class at least 24 hours prior to cancelation. Any such cancelation will not be charged to the USG and class hours canceled will carry over to complete the performance period. Any cancelations within 24 hours will not carry over and will be charged to the USG.
- b) The contractor will notify U.S. Embassy Ankara Contracting Officers Technical Representative of class cancelations due to instructors' incapacity to attend a particular class. Any such cancelation will not be charged to the USG and class hours canceled will carry over to complete the performance period.

### 3. SCHEDULE:

Class schedules will be developed by U.S. Embassy Contracting Officers Technical Representative, submitted to the contractor for confirmation and implemented upon final agreement by both parties.

### 4. USG AND CONTRACTOR FURNISHED PROPERTY

- a) The Contractor shall provide all instructional materials including texts, books, class exercises, CD's for listening lessons, handouts and tests.
- b) The USG shall provide training rooms that include furnishings and equipment necessary for an appropriate learning environment.
- c) The USG shall replenish such expendable/consumable items as needed to provide for the performance of the work.
- d) The Contractor shall provide qualified instructor(s) who are well versed in all topics to be covered, capable of answering in-depth questions on each topic in a classroom setting, and based upon the schedule of training modules lessons and goals for that training.
- e) The Contractor shall provide instructor supervisor(s) who will supervise the performance of work under the contract and who will perform quality assurance in meeting the objectives and goals for that training.
- f) The Contractor shall provide other required classroom materials such as newspapers, magazines, dictionaries, or photocopied materials written in the English language for use by students in exercises or testing.

## **5. SPECIFIC TASKS**

The contractor shall provide instructional English language training services at the firm fixed prices shown in the purchase order. The objectives of each training module or lesson are to prepare all students as efficiently and effectively as possible to accomplish the goals of the training.

### **GOALS OF FOREIGN LANGUAGE TRAINING**

The goal of training is to provide participants with the skills and knowledge necessary to rapidly reach the desired level of performance as identified in the training modules or lessons identified below:

#### **Beginner Level**

Upon completion of this level, the participant will be able to understand familiar expressions and respond in a simple manner, provided the other party speaks slowly and clearly.

#### **Elementary Level**

Upon completion of this level, the participant will be able to communicate in simple and straight forward expressions describing aspects that include common tasks, personal background information, direct surroundings, and matters in the field of various needs.

#### **Pre-Intermediate Level**

Upon completion of this level, the participant will be able to understand clear standard texts on familiar matters which frequently occur at work and during leisure time and will be able to provide a description of experiences, events, expectations and can provide reasons and explanations in support of opinions and plans.

### **Intermediate Level**

Upon completion of this level, the participant will be able to respond at a level of fluency and spontaneity producing a normal exchange with native speakers and will be able to set out a viewpoint on current matters and discuss the advantages and disadvantages of various options.

### **STUDENT TESTING**

The Contractor shall administer tests on knowledge and proficiency as a required element of evaluating the student's progress in the training module or lesson. The Contractor shall provide these tests periodically to:

- Determine the student's progress in training;
- Identify areas of weakness where supplemental training may be needed; and
- Quantify the student's then-current level of knowledge and proficiency.

Initial testing will be used to establish a baseline for measurement of knowledge and proficiency obtained and to determine the present level of the student, (e.g. beginning or intermediate). The Contractor shall use tests recognized and accepted by national professional associations and organizations.

### **STUDENT PROGRESS DOCUMENTATION AND TRAINING RECOMMENDATIONS**

The Contractor's instructor(s) shall be responsible for documenting each student's progress in training, and for preparing a training recommendation for each student. The student's progress will be reported to the student biweekly. The instructor will document the student's progress as measured performance under each lesson module. The Contractor shall prepare training recommendations that state specific plans for remedial or supplementary use of supportive training materials, or use of tutoring and personalized training techniques.

### **STUDENT COUNSELING**

The Contractor's instructor(s) shall be responsible for counseling each student in the student's performance and for preparing and discussing with the student any corrective actions which may assist the student in the improvement of his or her performance. The student's progress will be discussed with the student on a bi-weekly basis, and the Instructor shall document the training recommendations made to direct the student's progress. The Contractor shall provide weekly counseling to all students considered in danger of failing the proficiency tests. The counseling sessions should result in specific tasking for remedial or supplementary use of supportive training materials or use of tutoring and personalized training techniques, as needed, to improve student performance.

### **B. PERFORMANCE REQUIREMENTS SUMMARY**

**B.1 Contracting Officer's Technical Representative (COTR)**

The Contracting Officer's Representative (see clause 652.242-70 in Section 2 Addendum) will provide specific guidance and answer questions relative to the requirement described in paragraph D.1, above. The COTR for this contract is: HRO and Aysim Hasan Tel: 457 7451.

**B.1.1 SURVEILLANCE.** The COR will receive and document all complaints from USG personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

**B.1.2 STANDARD.** The performance standard is that the USG receives no more than **three (3)** customer complaints per month. If complaints for any of the services exceed the standard, the COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items).

**B.1.3 PROCEDURES.**

- (a) If any USG personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the circumstances and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

(1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,

(2) Discriminating in the award of subcontracts on the basis of religion.
