EXCELLENCY:

I have the honor to refer to the Agricultural Commodities Agreement between the Government of the United States of America and the Government of Turkey, dated February 21, 1963, n1 as amended, and to propose that the commodity table (export market values in millions) be further amended to read as follows: wheat, \$ 81.0; cottonseed and/or soybean oil, \$ 60.3; inedible tallow, \$ 4.5; corn, \$ 1.1; barley, \$ 1.4; ocean transportation (estimated), \$ 14.0; total, \$ 162.3.

In numbered paragraph 2 of the note of February 21, 1963, as amended, add the following sentence at the end of the paragraph:

"The Government of the Republic of Turkey agrees to prohibit exports of barley or products thereof [*2] during the period that United States barley is being imported and

utilized. However, should there be any exports of barley or products thereof, the Government of the Republic of Turkey will purchase with its own resources from free world sources an equivalent quantity of barley as offset."

I have the honor to propose that this note and your reply concurring therein shall constitute an agreement between our two Governments on the subject to enter into force on the date of your note in reply.
