II. PERFORMANCE WORK STATEMENT

1.0 INTRODUCTION

- a) Embassy of the United States of America, Abu Dhabi has a requirement to obtain services of a general contractor to perform work of repairing / replacing the existing walkways inside the Embassy compound.
- b) The contractor shall remove the existing deteriorated concrete walkways completely and lay new unit-pavers. There are some areas with only gravel or pavers and the Contractor shall replace those areas with unit-pavers as well. In addition concrete curbs shall be built where none exist to support the unit pavers and preparing the sub-grade for laying new pavers.
- c) Estimated total quantities of three different types of the existing surfaces that will be replaced with new unit pavers are indicated in the 'Schedule of Quantities' section. This is a fixed price contract and not based on unit rates and measurable quantities. The estimated quantities for finish surface areas are based on the AutoCAD drawings available with the Embassy. The Contractor may elect to verify these measurements prior to submission of cost proposal and the Contracting Officer's representative will facilitate such exercise.

2.0 GENERAL REQUIREMENTS

- a) The Contractor shall provide material, labor and tools equipment needed to complete the work described in this statement of work (SOW).
- b) The Contractor shall have all local permits to operate as a building construction or general maintenance contractor.
- c) The Contractor shall carry out activities in a manner that will allow access to the Embassy facilities at all times. Activities in the work areas shall be sequenced in multiple phases wherein quantity of finish surface area in each phase shall not exceed 500 Square meters. Some work may need to be scheduled on weekends / holidays and outside the normal business hours on work days. Normal business hours of the Embassy are 8:30 AM to 5:00 PM Sunday through Thursday.
- d) The Contractor shall survey site during solicitation phase and submit technical proposal with method statement covering sequencing, materials, quality control, safety

management and past performance. The past performance shall include list of similar work done.

- e) The Contractor shall perform work in diligent manner and achieve completion within the specified performance period.

3.0 CONTRACT ADMINISTRATION

- a) The Contractor shall not perform work that is outside the SOW unless directed in writing by the Contracting Officer (CO). Any work done by the Contractor outside the SOW without direction from the CO will be at the Contractor's own risk and at no cost to the Embassy.
- b) The CO shall provide a Notice to Proceed (NTP) to begin performance of work after the contract award.
- c) Facility Manager at the Embassy of his nominee shall be designated as Contracting Officer's Representative (COR) for administration of this contract. The COR shall coordinate schedule for each phase, approve technical submittals, inspect work, monitor progress, accept completed work, review invoices, review change orders, and issue/receive Government Furnished Items. The COR has the authority to direct the Contractor to stop performance of work if unsafe work conditions are observed.

4.0 RESPONSIBILITY OF THE CONTRACTOR

- a) The Contractor shall bear complete responsibility for management of construction activities at site. The Contractor shall assign a Project Coordinator (PC) to represent the Contractor at site and to manage the performance of work during currency of the contract. The PC shall have adequate English language skills to be able to communicate with CO and COR.
- b) The Contractor shall bear complete responsibility and management control for the sub-contracted services and shall not depute the sub-contractor to represent the Contractor in dealings with the Embassy.
- c) The Contractor shall bear complete responsibility for safe performance of work at site and comply with all local laws pertaining to construction labor and safety. In addition, the safety requirements relative to this SOW as contained in the USACE Manual EM 385-1-1 shall apply. In case of a conflict between the local laws and the requirements of EM 385-1-1, the stringent of the two shall apply. A soft copy of the USACE Manual EM 385-1-1 is available in the following link:

- d) The Contractor shall prepare and implement a safety management plan specific to the SOW based on hazards analyses of the activities. A copy of the safety management plan shall be provided to the COR for reference. The Contractor shall promptly report all mishaps / accidents at site to the COR.

- e) The Contractor shall prepare and institute a quality management plan specific to the SOW. The plan shall describe the standard operating procedures for technical approvals, procurement actions, site inspections, testing and corrective actions. The A copy of the quality management plan shall be provided to the COR for reference.
- f) The Contractor shall comply with security requirements and be responsible for conduct of employees and subcontractors at work site.
- g) The Contractor shall be liable for the damages caused by the Contractor's negligent performance of any of the services furnished under this contract.
- h) The Contractor shall provide warranty for workmanship and materials for 12 months from the date of final completion.

5.0 EXECUTION OF WORK AT SITE

- a) The COR and the Contractor shall review the method statement submitted with the technical proposal, before the contract award, and agree to a sequencing and phasing plan. The Contractor shall commence work in a phase only after completion and acceptance of work in the previous phase. The Contractor shall begin activities in a phase after ensuring availability of materials and tools. Each phase shall be cordoned off with temporary partitions to isolate the construction activities and to contain dust and debris.
- b) The Contractor shall neatly stage materials and tools in a designated location. No tools and materials shall be left in work area at the end of work-day. Keep the work areas clear of hindrances, trip hazards, and unused materials at all times. The Contractor shall be responsible for safe-keeping of materials and tools equipment at site.
- c) The Contractor shall not disturb or damage any of the adjacent property items (manholes, junction boxes, lighting fixtures, doors, windows, or metal/wood surfaces) and provide temporary protective covers in a manner acceptable to COR. The Contractor shall, prior to starting demolition work, move & cover moveable items away from construction phase in a manner acceptable to the COR. Following completion of work in each phase, the Contractor shall remove covers, clean the fixtures with approved method and return the moveable items to their original position. Do not use cleaning fluids that will alter the original finish or the fixtures.
- d) The Contractor shall contain construction debris in a construction dumpster and legally dispose it without causing overflow and spillage. The debris shall be transported and disposed-off frequently and quickly in such a manner to avoid undue accumulation at site.
- e) The Contractor shall remove temporary covers, scaffolding, barricades and clean the work site as acceptable to the COR after completion of each phase of work.

- f) The Contractor shall be responsible for providing self-powered construction equipment such as pneumatic hammers, bobcat, loaders, etc. The Contractor shall be responsible for providing temporary electric power and water for construction.

6.0 SPECIFICATIONS

- a) Demolish the existing deteriorated concrete walkways in the compound as identified in the attached floor plan and dispose legally. Existing concrete walkways and patios are 10 to 15 centimeters thick.
- b) Remove the existing gravel from areas in the compound as identified in the attached floor plan and dispose legally.
- c) Remove the existing unit pavers from areas in the compound as identified in the attached floor plan and dispose legally.
- d) Remove the existing concrete, gravel or pavers up to a depth that will allow a minimum thickness of sand bed for new unit pavers as indicated below.
- e) Provide and install pre-cast concrete curb blocks 30 centimeters high PASCO K32 or approved equal as indicated in the attached floor plan. Provide cast-in-place concrete foundation for pre-cast curb blocks. The foundation concrete shall be minimum 15 centimeters thick L-shaped and cast on compacted subgrade.
- f) Provide and lay Un-grouted Mortar-less Pavers (Unit-Pavers) in areas where concrete, gravel or existing pavers will be removed.
- g) The pavers shall be 8 centimeter thick solid PASCO make UNIBLOCK in Grey color or approved equal in quality and color. Other equal quality pavers manufactured by reputed manufacturers may be provided subject to approval by COR. The Contractor must identify such equal products before award of contract. Provide samples of colors and patterns of layouts for selection by COR.
- h) Do not use unit pavers with chips, cracks, voids, discolorations, and other defects that might be visible or cause staining in finished work.
- i) Engage skilled and experienced paver installers who have successfully completed installations similar in material, design, and extent to that indicated in this SOW.
- j) Obtain unit pavers, from a single source with consistent quality in appearance and physical properties.
- k) Obtain quality controlled, graded aggregate for sub-base material and washed fine gravel for base material. Sand for leveling course shall be Fine, sharp, non-plastic aggregate complying with BS 882. Sand for Joints shall be per BS 882 with 100 percent passing the No. 8 sieve.

- l) Compact soil sub-grade uniformly and place graded aggregate for sub-base and base over compacted sub-grade. Provide minimum compacted thickness of 10 centimeter for base and sub-base.
- m) Place sand for leveling course taking care of the moisture content such that it remains constant and the density is loose and constant until concrete pavers are set and compacted.
- n) Set pavers with a minimum joint width of 1.5 mm and a maximum of 5 mm, being careful not to disturb leveling base.
- o) Vibrate concrete pavers into leveling course with a low amplitude plate vibrator that is capable of a 25 to 35 MPa compaction force and with rubber base. Perform at least 3 passes across paving with vibrator. Spread dry sand and fill joints immediately after vibrating pavers into leveling course. Brush and vibrate sand until joints are completely filled and then remove surplus sand. Do not allow traffic on installed concrete pavers until sand has been vibrated into joints.
- p) Coordinate with COR for installation of new underground utilities provided by others.
- q) Provide samples of pavers and color shades for the COR to choose from.

7.0 DELIVERABLE SCHEDULE

- a) The Contractor shall commence work under this contract promptly, execute the work diligently, and achieve final completion and acceptance including final cleanup of the premises within the contract period specified.
- b) Total period of performance for base requirement shall be 10 weeks from the date of NTP.

8.0 SECURITY REQUIREMENTS

- a) The Contractor shall, after award of the contract, provide information on each employee who will be working at the Embassy site under the contract. Contractor shall include a list of workers and supervisors assigned to this project. Furnish passport copy, residence visa / work visa copy, and completed Form DS-174 for each of the personnel to facilitate clearance by Embassy security office. Security office will run background checks on these individuals. It is anticipated that it will take four (4) weeks to perform the background checks. Each of the personnel will be required to obtain local police clearance certificate as part of the background checks. The Embassy shall provide necessary request letter addressed to the police department.
- b) The Contractor shall coordinate material and equipment deliveries with the COR who in turn will coordinate it with the Embassy security office for access approval. The Contractor shall provide vehicle and delivery personnel information in advance.

9.0 PAYMENTS

- a) This is a Firm-Fixed price contract. The Contractor shall submit monthly progress payment request on the basis of work completed. The COR will review and recommend the invoice for payment.
- b) The Contractor shall specifically identify the last invoice as "Final Invoice." The final invoice shall include the remaining payment claimed to be due under the base contract and all modifications issued, if any. The final invoice shall also have the Contractor's Release of Claims Certificate and the Workmanship Warranty attached.

12.0 INSURANCE

Amount of Insurance

The Contractor is required to provide whatever insurance is legally necessary under Section I, 52.228-5, "Insurance - Work on a Government Installation." The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

1. Bodily Injury on or off the site stated in AED:

Cumulative AED 1,500,000

2. Property Damage on or off the site in AED:

Cumulative AED 1,500,000

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

any property of the Contractor, its officers, agents, servants, employees, or any other person, arising from an incident to the Contractor's performance of this contract.

The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

B. Government as Additional Insured

The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

C. Insurance-Related Disputes

Failure to agree to any adjustment contemplated under this contract regarding insurance shall be a dispute within the meaning of FAR 52.233-1, Alternate I, "Disputes". Nothing in this clause shall excuse the Contractor from proceeding with the work, including the repair and/or replacement as herein above provided.

Time for Submission of Evidence of Insurance

The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. Failure to timely submit this evidence, in a form acceptable to the Contracting Officer, may result in rescinding or termination of the contract by the Government.

13.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. **PROCEDURES.**
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
 - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
 - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
 - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.




