

**JUSTIFICATION AND APPROVAL FOR OTHER THAN FULL AND OPEN
COMPETITION (OVERSEAS CONTRACTING ACTIVITIES)**

1. I recommend that Embassy *Abu Dhabi* use other than full and open competition for the acquisition of *Spare parts stock for maintenance of the drop arm barriers at the Embassy*. The estimated cost *may be over \$3,000*.
2. Nature and/or description of the action being approved. – *Procurement of spare parts for the drop arm barriers for Facilities Management spares stock*.
3. A description of the supplies or services required to meet the agency's needs. – *Spare parts as listed below*.
 - *1 assembly PC assembly connection panel for G-90 CD series Federal APD brand Drop Arm Barrier equipment, Part # 23-8703*
 - *3 ea Omega LCD controller for G-90CD series Federal APD brand Drop Arm Barrier equipment, Part # 23-10235*
 - *4 ea Vee Belt, - 27" for G-90 CD series Federal APD brand Drop Arm Barrier equipment, Part # 21 - 0656*
4. An identification of the statutory authority permitting other than full and open competition. *FAR 6.302-1(c)*
5. A demonstration that the proposed contractor's unique qualifications or the nature of the acquisition requires use of the authority cited (for sole source acquisitions; also required for unusual and compelling urgency where more than one offer will not be solicited). – *We need the specified brand-name parts, which will fit in the existing equipment when a repair / maintenance is required so the whole system does not have to be replaced*.
6. A description of efforts made to ensure that offers are solicited from as many potential sources as is practicable. The description should include whether a FedBizOpps notice was or will be publicized, as required by FAR 5.2, and if not, which exception under FAR 5.202 applies (e.g., blanket waiver provided in DOSAR 605.202-70). – *The parts may be procured from any dealer of the brand*
7. A determination by the Contracting Officer that the anticipated cost to the Government will be fair and reasonable. – *Brand specific items due to existing system within the building, all quotes will be considered*.
8. A description of the market survey conducted and the results or a statement of the reasons a market survey was not conducted. – *Market research was not conducted since this request is brand name specific*.
9. Any other facts supporting the use of other than full and open competition. – *The requisitioned items are part of an existing building system*.

10. A listing of sources, if any that expressed, in writing, an interest in the acquisition.




