1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform janitorial work, including furnishing all labor, material, equipment and services, for the U.S. *Embassy Kampala*. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for standard services and a fixed rate per square meter for any temporary additional services that have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

Starting on date of award and continuing for a period of twelve months;

Because Temporary/Additional Services are based on indefinite delivery/indefinite quantity the minimum and maximum amounts are defined below:

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months.

1.1 VALUE ADDED TAX

SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20
DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. SCOPE OF WORK

The purpose of this fixed price contract is to obtain janitorial services for real property owned or managed by the U.S. Government at **American Embassy Kampala CSL Site-Entebbe**. The Contractor shall perform janitorial services in all designated spaces including, but not limited to halls, offices, restrooms, work areas, entrance ways, lobbies, storage areas, elevators and stairways, the compound, gabbage collection. The contract will be for a one year period from the date of the contract award.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

1.1 General Instructions

The Contractor shall prepare general instructions for the work force. The Contractor shall provide drafts to the Contracting Officer's Representative (COR) for review within thirty days after contract award. The Contracting Officer's Representative must approve these general instructions before issuance.

1.2 Duties and Responsibilities

1.2.1 Certain areas listed in paragraph #3 require an escort and can only be entered during scheduled times. The General Instructions shall emphasize security requirements so that accidental security violations do not occur.

1.2.2. Contractor shall schedule routine cleaning requirements to ensure that these are done in the order and time frame that are most efficient and have the least impact on normal operations. They are to be performed on a daily basis.

1.2.3. Contractor shall schedule periodic cleaning requirements so that it causes minimal disruption to the normal operation of the facility. The COR shall determine the schedules presented which meet the needs of the individual facility.

1.2.4. Temporary Additional Services are services that are defined as Standard Services but are required at times other than the normal workday. These services shall support special events at the site. The Contractor shall provide these services in addition to the scheduled services specified in this contract. The COR shall order these services as needed basis. This work shall be performed by Contractor trained employees, and

shall not be subcontracted. The COR may require the Contractor to provide temporary additional services with 24 hour advance notice.

- 1.2.5 The Contractor shall include in its next regular invoice details of the temporary additional services and, if applicable, materials, provided and requested under temporary additional services. The Contractor shall also include a copy of the COR's written confirmation for the temporary additional services.

1.3 Types of Services

Standard Services shall include the following work:

1.3.1 **General:**

- A. This is an annual service and it includes but not limited:

Cleaning of showers and bathroom units shall be provided on a two day per week schedule, or as circumstances may warrant for additional days.

- Grounds/compound maintenance shall be provided once weekly.
- Garbage removal shall be provided 36 times per year as directed by CSL site manager.
- Pest control shall be provided once monthly.

All janitorial cleaning and maintenance shall be performed between the hours of 8:30 a.m. and 4:00 p.m., Monday and Thursday, or by appointment scheduled in advance. The Contractor shall notify the site manager of any deviation to the previously agreed upon appointment and schedule an alternate appointment for cleaning.

- B. The site manager shall unlock doors for the Contractor and shall be physically present and visible in the facility during all cleaning at the scheduled appointment time. The site manager shall be present in the facility a minimum of 15 minutes prior to the scheduled appointment time and wait a maximum of 30 minutes beyond appointment time for the Contractor to arrive for cleaning, after which time the Contractor shall be deemed to have not met the appointment. A no-show by the Contractor shall be reported immediately via the chain of command to the USARAF LNO, Embassy OSC and GSO procurement and must be recorded on the janitorial checklist. If the site manager is a no-show (fails to be available to open the facility a maximum of 30 minutes beyond appointment time) the contractor will not make up that day's cleaning and shall report to clean on the next scheduled appointment time with no penalty assessment. The contractor shall immediately report a no-show by site manager to the Embassy GSO procurement and Embassy OSC. No cleaning shall be accomplished on established Embassy Holidays, unless it is deemed necessary by the site manager due to current missions. If a Federal Holiday occurs

on one of the regularly scheduled cleaning days, the Contractor shall perform the cleaning on the next scheduled cleaning day. The Contractor shall ensure that cleaning services occur at least twice per week. **No keys to Government facilities are to be provided to Contractors under any circumstances.**

- C. The Service Checklist (see enclosed) shall be provided to the contractor manager. The checklist shall be completed by the janitorial Contractor and signed at the completion of each week's cleaning. The site manager will also sign signifying that the specified work has been completed in a satisfactory manner. If service on checklist is not required to be rendered that week N/A will be placed in the box next to the task. This checklist shall be used by the Contractor.
- D. Emergency Services. Upon notification by the CSL Site manager, the Contractor shall respond within a half day, if at all practicable. The Contractor shall perform emergency services required due to mission requirement, broken or leaking pipes, sinks, toilets or other occurrences requiring immediate corrective action to restore an area to its normal state of cleanliness and appearance. Additional removal of garbage from site as required. Emergency services will be 100% inspected and shall be compensated in accordance with the item completed on bid sheet in addition to the normal compensation paid under the contract.
- E. The Contractor shall provide all necessary labor, transportation, tools, materials, equipment, and supplies required to perform services. All cleaning procedures and treatments shall be accomplished in accordance with the manufacturer's directions and/or listed specifications and industry standards applicable to the Professional Cleaning and Restoration Industry.
- F. The following table of services should be used as a guide and bid for obtaining janitorial services for CSL facilities in compliance with above guidance:

Scheduled Services:

- 1) Clean & disinfect multipurpose facility and containerized living units. To include but not limited to:
 - a. Floors, walls, windows & blinds.
 - b. Furniture inside buildings.
 - c. Remove garbage from inside buildings.
 - d. Disinfect waste receptacles, replace garbage sack.
- 2) Clean and disinfect shower and bathroom units. To include but not limited to:
 - a. Floors, walls, dividers and shower stalls.

- b. Sinks, fixtures, mirrors and windows.
 - c. Urinals and toilets.
 - d. Remove garbage.
 - e. Disinfect waste receptacles, replace garbage sack.
 - f. Replace toilet paper, paper hand towels and hand soap (from supplies on site).
- 3) Grounds maintenance. To include but not limited to:
- a. Pick up trash around the grounds of the facility.
 - b. Cut grass inside fenced area and along outside of fence in front between road and fence.
 - c. Remove grass cuttings.
 - d. Sweep cement drive & walkways.
 - e. Clean walkway between living units & wipe down outside of CLU walls along walkway.
- 4) Garbage removal. To include but limited to:
- a. Remove garbage from CSL site.
- 5) Pest control. To include but not limited to:
- a. Treat facility for rodents and insects inside and outside of buildings
 - b. Treat shipping containers for rodents inside and outside.

Frequency of tasks:

- 1) Item 1 shall be conducted once per week. Item 2 shall be conducted two times weekly on Tuesday and Thursday (option to adjust work day for holidays).
- 2) Item 3 shall be conducted once weekly during regular scheduled visit. Item 3 can be done over 2 work days.
- 3) Item 4 shall be conducted by request from CSL site manager up to 36 times per year.
- 4) Item 5 Shall be conducted once monthly.
- 5) All items shall have the option to add additional service based on site needs.

Billing:

This is to provide 1 month of service to be billed through the US Embassy Kampala, Financial Management Center (FMC). Any extra services needed will be added to the monthly bill and stated on a separate line from regular services. Additional services on bill will be signed off by site manager.

Summary:

Services shall be monitored by CSL site manager and USARAF LNO. Invoices shall be sent to US Embassy Kampala, Financial Management Center for processing and a copy will be

sent to the USARAF LNO. All problems and conflicts regarding service, contract fulfillment and payment will be directed to site manager and USARAF LNO. Failure to provide complete services could end in termination of contract.

Interference with Government Business:

The Contractor shall schedule and arrange work so as to cause the least interference with the normal occurrence of Government business and mission. In those cases where some interference may be essentially unavoidable, the Contractor shall be responsible to make every effort to minimize the impact of the interference, inconvenience, customer discomfort, etc. Some areas of the CSL may be off limits or may require an escort for non US military personnel. During exercise areas determined off limits by occupying units will not be entered by contractors. Entering off limits areas may result in termination of contract.

Protection of Government Property:

During execution of the work, the Contractor shall take special care to protect Government property including furniture, walls, baseboards, and other surfaces from materials not intended. Accidental damage shall be reported immediately to the CSL site manager. The Contractor shall return areas damaged as a result of work under this contract to their original condition, to include painting, refinishing, or replacement, if necessary.

If work is not performed by the Contractor personally, then a bona fide supervisor with full authority to represent the Contractor shall be required to visit the work site at least twice a month to verify the work is being accomplished as specified. This representative must be someone other than the person performing the work.

Contractor shall ensure that all employees and/or subcontractors have adequate knowledge of chemicals, equipment and techniques necessary to perform work. The site manager or USARAF LNO may require the Contractor to discontinue using any employee or subcontractor, determined by the above mentioned to be unsatisfactory

Definitions:

As used throughout this document, the following terms shall have the meaning set forth below. Addition DEFINITIONS shall be considered common sense considerations and industry standards.

- 1) **Site Manger.** Refers to the full time employee from the US embassy and USARAF assigned to manage the CSL site.
- 2) **USARAF LNO.** US military personal assigned to oversee the CSL site and form USARAF.

- 3) **GSO Procurement.** General Services Office procurement US Embassy.
- 4) **OSC.** Office of Security Cooperation US Embassy Kampala, Uganda.
- 5) **USARAF.** United States Army Africa.
- 6) **CSL.** Cooperative Security Location.
- 7) **Contractor.** Refers to both the prime contractor and any subcontractors or personnel. The prime Contractor shall ensure that his/her subcontractors comply with the provisions of this contract.
- 8) **Clean.** Shall be defined as free of dirt, dust, spots, streaks, stains, smudges, litter, debris and other residue.
- 9) **Disinfect.** Cleaning in order to destroy any harmful microorganisms by application of an approved environmental-friendly chemical agent to destroy micro-organisms.
- 10) **FMC.** Financial Management Center
- 11) **Frequency of Service.**
 - a. **Weekly.** Service to be performed one time a week every week during the specific length of the contract.
 - b. **Two times Weekly.** Service to be performed twice a week every week during the specific length of the contract.
 - c. **Monthly.** Service to be performed one time a month every month during the specific length of the contract.
 - d. **Two times Monthly.** Service to be performed two times a month every month during the specific length of the contract.

2.0 MANAGEMENT AND SUPERVISION

- 2.1 The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff. The supervisor shall have supervision as his or her sole function.
- 2.2 The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.
- 2.3 The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

2.4 The Contractor shall control overtime through efficient use of the work force. Individual work schedules shall not exceed 40 hours per week to preclude overtime being part of the standard services provided under the contract. Overtime may be necessary under Temporary Additional Services.

3.0 LOCATIONS FOR JANITORIAL SERVICES

All standard services are to be delivered on regular Embassy working days and when called upon by the site management.

Multipurpose Facility (MPF)

Containerized Housing Units

Shower Units

Bathroom Unit

Grounds Maintenance

4.0 PERSONNEL

4.1 General. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

4.2 Standard of Conduct.

4.2.2 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR).

4.2.3 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

4.2.4 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

4.2.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

- 4.2.6. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:
- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
 - unauthorized use of Government property, theft, vandalism, or immoral conduct;
 - unethical or improper use of official authority or credentials;
 - security violations; or,
 - organizing or participating in gambling in any form

4.2.7 Key Control. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system.

4.3. Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

4.4. Personnel Security

4.4.1 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will 14 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Identification number

4.2 The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of

the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

5.0. MATERIALS AND EQUIPMENT

The Contractor shall provide all necessary janitorial supplies and equipment, including mops, brooms, dust rags, detergents, cleaners, etc. to perform the work identified in this contract.

6.0. GOVERNMENT FURNISHED PROPERTY/EQUIPMENT

6.1 The Contractor has the option to reject any or all Government furnished property or items (see Attachment 1 - GOVERNMENT FURNISHED PROPERTY). However, if rejected, the Contractor shall provide all necessary property, equipment or items, adequate in quantity and suitable for the intended purpose, to perform all work and provide all services at no additional cost to the Government. All Government furnished property or items are provided in an "as is" condition and shall be used only in connection with performance under this contract. The Contractor is responsible for the proper care, maintenance and use of Government property in its possession or control from time of receipt until properly relieved of responsibility in accordance with the terms of the contract. The Contractor shall pay all costs for repair or replacement of Government furnished property that is damaged or destroyed due to Contractor negligence.

6.2 The Contractor shall maintain written records of work performed, and report the need for major repair, replacement and other capital rehabilitation work for Government property in its control.

6.3 The Contractor shall physically inventory all Government property in its possession. Physical inventories consist of sighting, tagging or marking, describing, recording, reporting and reconciling the property with written records. The Contractor shall conduct these physical inventories periodically, as directed by the COR, and at termination or completion of the contract.

7. INSURANCE

7.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

7.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

1. Bodily Injury stated in U.S. Dollars:
Per Occurrence USD 9,000.
Cumulative USD 90,000
2. Property Damage stated in U.S. Dollars:
Per Occurrence USD 20,000
Cumulative USD 100,000

7.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

7.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

7.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

7.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

7.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

7.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

8.0. LAWS AND REGULATIONS

8.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

8.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

9.0. TRANSITION PLAN

Within 5 days after contract award, the Contracting Officer may request that the Contractor develop a plan for preparing the Contractor to assume all responsibilities for janitorial services. The plan shall establish the projected period for completion of all clearances of Contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

11. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

11.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

11.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

11.3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
