SCOPE OF SERVICES

Introduction

Rakai Health Sciences Program (RHSP), Uganda is seeking for a way to merge data from various remote OpenMRS installations to facilitate for a centralized data extraction. Currently, data is extracted from the various remote sites using a hard drive uploaded to an OpenMRS platform and queried (which is a cumbersome exercise).

Rakai Health Sciences Program implements stand-alone OpenMRS software in 17 remote Health facilities providing HIV treatment and care services, but the same concept dictionary. The sites currently run a mixture of OpenMRS version 1.6.3 and 1.10.0. Most of the health facilities don't have internet connectivity and data management files are routinely transported using external storage drives.

Problem Statement

RHSP is interested in merging the 17 stand-alone OpenMRS databases into one OpenMRS instance for the retrospective data, and upgrade the current OpenMRS implementation to allow for a centralized merging of the prospective data.

Task 1: One-time Merging 17 stand-alone OpenMRS instance into one OpenMRS instance

Objective: To develop one merged OpenMRS instance for the retrospective data in the current OpenMRS system

Task	Description	Deliverable
1:1	All patient data across the 17 health facilities to appear in one OpenMRS instance.	One Open MRS instance Preserving with the patient data as in the stand-alone instance

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation,” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

Sensitive technology—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

- (1) Means a small business concern—
 - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(b) Certification. By submitting this offer, the offeror certifies that it is not:
