Statement of Work

The contractor/editor shall write, prepare, edit and submit an issue of The Trident on Wednesday of each week.

This newsletter is a weekly publication aimed at the official American community and their families. The paper's length varies depending upon material available. The minimum length is 12 pages and the maximum length will vary according to the needs of the community as determined by the COR/CLO but not exceed 17 pages (average is 15 pages). The software used is Microsoft Publisher.

The contractor shall provide the worksite and equipment necessary to produce this newsletter.

Not later than Wednesday midnight of each week, the Contractor will e-mail the completed work product to:

Not later than 11:00 am Thursday after the receipt of newsletter, the CLO shall notify the contractor that the newsletter as submitted is acceptable or will require revisions. If revisions are required, they must be completed by the Editor and the final newsletter re-submitted to the CLO no later than 3:00 pm the same day.

The newsletter shall be published electronically via e-mail, by the Community Liaison Office (CLO). Final decisions of publication will be determined by the CLO in all matters relating to suitability of the publication as well as style and graphic options.

Major duties and responsibilities:

- The Editor will find new material, write their own articles and arrange articles submitted by the Contracting Officer Representative (COR) in a topic specific and orderly fashion onto pages of the newsletter. All printed material shall be Embassy related to maintain high morale within the community. Material should include holiday related topics. All materials, including pictures, must be properly annotated.

- The Editor will check and correct spelling and grammar of submitted materials including all classified ads.

- The Editor will check all submitted articles to make sure they are suitable for publication and will be open to last minute additions from the CLO as well as the Embassy community.

- The Editor must notify COR in writing one week in advance, if unable to submit an issue on time, in order to have ample time to publish the issue by its own means. The CLO will respond within 24 hours acknowledging the request of the Editor.

- The Editor will submit Newsletter to COR by e-mail, in publisher, on a weekly basis, 52 issues per year, unless the Embassy is closed due to a holiday or other emergency situations. COR will inform the Editor an alternative day of Newsletter submission when holiday schedules dictate such.

- Attend quarterly meetings to discuss items related to the publishing of the Trident. Items for discussion may include (but not limited to) format, suitability of content or new material and upcoming events. The time will be set up by CLO and contractor will be notified at least 5 days before the meeting. Meetings will be held at CLO office.
- COR/CLO has the right to edit or change the Trident articles if they find something unsuitable for publishing.

Contract performance may require contractor personnel to attend meetings with government personnel and the public, work within government offices, and/or utilize government email.

ACQUISITION METHOD

The Government is conducting this acquisition using the simplified acquisition procedures in Part 13 of the Federal Acquisition Regulation (FAR).

SECTION 4 - EVALUATION FACTORS

The Government intends to award a contract/purchase order resulting from this solicitation to the lowest priced, technically acceptable offeror/quoter who is a responsible contractor. The evaluation process shall include the following:

- a) **Compliance Review.** The Government will perform an initial review of proposals/quotations received to determine compliance with the terms of the solicitation. The Government may reject as unacceptable proposals/quotations which do not conform to the solicitation.
- b) **Technical Acceptability.** Technical acceptability will include an evaluation of information defined in Section 3, along with any technical information provided by the offeror with its proposal/quotation.
- c) **Price Evaluation.** The lowest price will be determined by multiplying the offered prices times the estimated quantities in “Prices - Continuation of SF-1449, block 23”, and arriving at a grand total, including all options. The Government reserves the right to reject proposals that are unreasonably low or high in price.
- d) **Responsibility Determination.** The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:
 - adequate financial resources or the ability to obtain them;
 - ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
 - satisfactory record of integrity and business ethics;
 - necessary organization, experience, and skills or the ability to obtain them, such as:

- **Prior Work Experience:** Prior experience with familiarization of newsletter or other publication processing; document processing; graphic design or any related field to demonstrate written or visual communication skills.

- **Language:** Fluent knowledge of written and oral English is required. Must be able to demonstrate knowledge of English grammar and punctuation rules. A writing sample shall be submitted with solicitation. The sample should demonstrate ability to write articles on subjects relevant to the Embassy community or similar nature. For example, cultural events and holidays (host country and/or United States of America), living in a foreign country, etc.

- **Knowledge:** Must be familiar with publishing layout and design features of standard desktop publishing software (example: MS-Publisher), MS Office, knowledge of Page Maker, Adobe Acrobat is a plus. Basic familiarity with local and national culture and practices of Ukraine and US Mission life is required.

- **Skills and Abilities:** Must be able to effectively use desktop publishing software and keyboard skills; editing skills; layout and graphic skills. Must be resourceful and creative with dealing when individuals of every background. The ability to produce and deliver high-quality work within a firm weekly deadline is essential.
