GRADE LEVEL: FSN-03, FP-BB* (FULL PERFORMANCE LEVEL)

WORK HOURS: Full Time, 40 hours per week

POSITION TYPE: PERMANENT

OFFICE LOCATION: General Services Office/Motor Pool

OPENING DATE: Immediate

DEADLINE: November 18, 2015 at 6 P.M. Kyiv Time

IMPORTANT NOTE:

ALL ORDINARILY RESIDENT U.S. CITIZEN AND THIRD COUNTRY NATIONAL APPLICANTS MUST HAVE THE REQUIRED RESIDENCY PERMIT TO BE ELIGIBLE FOR CONSIDERATION AND ARE REQUESTED TO ATTACH COPY OF THEIR **RESIDENCY PERMIT** TO THE APPLICATION.

BASIC FUNCTION OF POSITION:

Serves as a chauffeur to transport Embassy personnel and provide courier service in support of Mission requirements. The incumbent may drive a bus or light armored vehicle (LAV) as necessary.

REQUIRED QUALIFICATIONS:

EDUCATION:

- Completion of secondary school is required.

PRIOR WORK EXPERIENCE:

- Chauffeurs shall have a minimum of two years of experience as a chauffeur or two years of experience as a driver in commerce, public transportation, or similar backgrounds. Incidental operators shall have had a driver's license for a minimum of 5 years.

LANGUAGE PROFICIENCY:

- Level II (limited knowledge) English is required.
Level III (good working knowledge) Ukrainian and/or Russian is required.

JOB KNOWLEDGE:

- Basic technical knowledge of automotive systems and mechanisms. Thorough knowledge of local traffic law. Must be knowledgeable of city streets and traffic patterns, locations of major buildings, organizations, and government offices; of vehicle maintenance procedures.

SKILLS AND ABILITIES:

- Must possess valid Driver license (B, C, D) and be able to drive Government owned vehicles (GOV) including LAVs, vans, buses and SUVs. Must be in a good health condition, in order to obtain medical certification. Must be able to deliver passengers/materials in a timely and safe manner, proving good customer service and support.

APPLICATION AND SELECTION PROCESS:

✓ Effective August 1, 2010 Office of Overseas Employment announced new Universal Application for Employment (DS-174) as a mandatory application for any locally recruited positions. To apply for this position all interested candidates should fill out the DS-174 and submit it to the Embassy Human Resources Office by **November 18, 2015**. Note: Only those applications that are received in the Human Resources Office *before* the closing date will be eligible for consideration. Any application package that doesn't include the UAE (DS-174) will be considered incomplete and will not receive further consideration for recruitment.

ADDITIONAL SELECTION CRITERIA:

- Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
- Current employees serving a *probationary period* are not eligible to apply for this position.
- Current Ordinarily Resident employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
- US Citizen EFMs who are currently employed under *Family Member Appointment* (FMA) must work for 90 calendar days in their current position before being able to apply for advertised position.
- US Citizen EFMs and NORs who are currently employed under *Personal Services Agreement* (PSA) must work for 90 calendar days in their current position before being able to apply for advertised position.
- U.S. Veterans and U.S. Citizen EFMs will be given preference in hiring over other *equally qualified candidates* in accordance with Section 301 (c) of the Foreign Service Act of 1980. Candidates who claim *U.S. Veterans hiring preference* must provide a copy of their Form DD-214 with their application. Candidates who claim U.S. Citizen EFMs hiring preference should indicate their EFM status in the application form.
- Only those applicants who are selected for the interviews will be contacted.
