1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform gardening services at Chief of Mission Residence (CMR) located at 5 Pokrovska St., Kyiv, Ukraine. The Contractor shall maintain the CMR gardens in a continuously finely manicured condition and removing snow to keep walkways and driveways clear and safe in cold weather as is described in the Scope of Work.

The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for the performed services.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with two one-year options to renew. The initial period of performance includes any transition period authorized under the contract.

1.1 VALUE ADDED TAX

Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. A. SCOPE OF WORK

1.0 General

1.1 Introduction

This Scope of Work is for maintaining the CMR gardens in a continuously finely manicured condition and removing snow to keep walkways and driveways clear and safe in cold weather as is described in this Scope of Work.

1.2 Background

The areas currently are being maintained by the Embassy Facility Maintenance (FAC) staff on a temporarily basis, until a service contractor can assume these duties.

1.4 Objective

The objective is for a service contractor to maintain the CMR gardens in a clean, safe, well-manicured condition and keep the property appealing in appearance at all times. The condition and appearance is to be at all times suitable for U.S. Government representational events. The lawn will be manicured and all trees, shrubs, and flowers will be maintained in a healthy condition. Snow removal is to be performed as needed to keep the walkways and driveways safe from slipping and sliding.

2.0 Scope of Work

2.1 Gardening

- 2.1.1 Sweep entry way exterior landings daily.
- 2.1.2 Provide cleaning of gutters/down spouts systems after the leaves have fallen and in early Spring after snow melt.
- 2.1.3 Collect fallen leaves and put in the dumpster daily during the Fall until the leaves are all gone.
- 2.1.4 Sweep sidewalks inside and outside the fence and paved areas daily.
- 2.1.5 Maintain grass height of 6-7 cm and check it once a week.
- 2.1.6 Reseed/replant any dead or thin areas.
- 2.1.7 Aerate each lawn at least once a year in late spring using garden forks or an aerator machine.
- 2.1.8 Apply high potash fertilizer and compost around the bases of flowering plants, shrubs, and trees two times a year.
- 2.1.9 Flower beds, lawns, and around trees and shrubs, will be weeded by hand or with a hoe. When herbicides are required, Contractor will notify the Embassy GTM. Only Embassy approved herbicides may be used.
- 2.1.10 Fertilize the lawn each year at the beginning of the growing season. All grass areas to be fertilized as needed. In some cases more or less may be required depending on annual weather and turf species. All fertilizers and application schedules shall be approved by the COR.
- 2.1.11 Provide insect control when required. The Contractor will notify an Embassy GTM before applying insecticides. Only Embassy approved insecticides may be used. The Embassy will provide the insecticides to the Contractor. Spraying for insect control, all turf/grass will be monitored during maintenance program to ensure early detection of existing or anticipated problems. Contractor shall focus on maintaining healthy turf/grass. If insects are suspected to be causing a problem with plants, the Contractor will contact the COR and suggest a method of pest management to maintain a healthy turf.
- 2.1.12 Tree care with trimming:
 - 2.1.12.1 Woody type tree should be allowed to form a natural canopy head. A clear truck of approximately six (6) feet in height will be provided to allow shade and good visibility.
 - 2.1.12.2 Sucker growth, considered to be all new shoots that appear at the base of the tree trunks or limbs below the foliage canopy will be removed. Remove dead and damaged branches.
 - 2.1.12.3 Any limbs removed from trees shall be removed at the shoulder to insure proper overgrowth of bark and protection from core rot.
 - 2.1.12.4 All trees crowns/canopies, including those thirty feet (30ft) above the ground and higher, are included in this contract.

- 2.1.12.5 Tree will be fertilized upon COR approval, trees to be fertilized 2 times per year as a guideline. Other nutritional supplements will be added if a deficiency exists.
- 2.1.13 Contractor shall focus on maintaining healthy plants that stimulate their natural defense system. NO/NO applications of pest control products will be done without the written approval of the COR prior to applications. NO exceptions. However, if pests become a problem, the contractor will recommend to the COR a method to maintain a more natural balance. Keep litter and debris removed from the grounds. Collect and remove clippings from the lawn. Rake and remove any leaves from the lawn.
- 2.1.14 Prune all shrubs and maintain them in a manicured condition.
- 2.1.15 Notify GTM in the event of a large tree limb damage to arrange for limb removal.
- 2.1.16 Prune any damaged, dead, or crossing branches.
- 2.1.17 Trim hedges regularly to avoid having to cut them back too much at any one time.
- 2.1.18 Use string trimmer to cut down grass around fences and structures that remains after mowing.
- 2.1.19 Dispose of all trimmings/pruning.
- 2.1.20 Water plants, shrubs, lawn and trees so that they do not appear stressed or wilting. This may require watering more than once each week. An irrigation system exists, but watering may be necessary if the system fails or in extreme dry periods.
- 2.1.21 Sweep all paved, tiled, and concrete areas including, but not limited to, driveways, terraces, stairs, and walkways after mowing.
- 2.1.22 Pressure wash or scrub clean all paved, tiled, and concrete areas including, but not limited to, driveways, terraces, stairs, and walkways at least twice each year.
- 2.1.23 Rake leaves from all surfaces.
- 2.1.24 Keep litter and debris removed from the grounds.
- 2.1.25 The contractor shall be responsible for the disposal of all trash created while performing work. The contractor shall transport all materials to be disposed of from the point of removal to the designated disposal storage site (dumpsters), and shall ensure that all items removed through this work are disposed properly.

2.2 Snow and Ice Removal

- 2.2.1 Remove snow from joining roads and sidewalks outside the perimeter fence by 8:00 AM.

- 2.2.2 Remove snow from walkways and pavement inside the perimeter fence by 9:00 AM.
- 2.2.3 When removed snow accumulation is too great for the property the snow must be removed from the property.
- 2.2.4 A salt based deicer must be applied at frequent enough intervals to prevent ice and snow accumulations after the initial snow removal.
- 2.2.5 Snow removal inside the campus must be performed each snow day of and as requested for special events. Each snow day the sidewalks outside the campus must be cleared.
- 2.2.6 The contractor shall provide daily check and remove icicles from roof overhangs.
- 2.2.7 In case of heavy snowfalls the contractor shall be ready to work on removing snow on weekends and evenings as requested.
- 2.2.8 The contractor shall use appropriate equipment, tools and deicers, approved by COR.

2.3 Supplies, Repair Parts, and Tools

- 2.3.1 The contractor shall provide all necessary materials and supplies such as gloves, fertilizer, trimmer string, mulch, and etc. to perform the work.
- 2.3.2 Deicer will be furnished by the U.S. Government.
- 2.3.3 Lawn mowers, string trimmers, snow blowers, rakes, shovels, hoes, scoops, hand tools, tool boxes, brooms and etc... are to be furnished by the contractor and made available for timely execution of the required work.

2.4 Safety Practices

- 2.4.1 Contractor shall follow Safety policy and be subject to review of safety practices by the GTM, COR, POSHO, and APOSHO.
- 2.4.2 Each contractor performing maintenance/contract work in a US Government facility shall be subject to the provisions of the OSH Act of 1970, and the current safety standards including OSHA 1910 (general industry) and 1926 (construction).
- 2.4.3 All on-site employees of the Contractor and its Subcontractors shall be required to perform this SOW according to the standards, policies and procedures equal to or more stringent than those found in OSHA's latest edition of the 1910 (General Industry) & 1926 (Construction).
- 2.4.4 It is the contractor's responsibility to promote good safety practices and eliminate hazards during the performance of work.
- 2.4.5 Work must be performed in a manner that provides a safe environment for the maintenance technicians and customers.
- 2.4.6 The contractor is responsible for ensuring that their employees comply with all applicable regulations, industry accepted safety practices and guidelines, as they apply to their discipline of work.

4.0 PERSONNEL

4.1 General. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

4.2 Standard of Conduct.

- 4.2.1 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR).
- 4.2.2 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.
- 4.2.3 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.
- 4.2.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.
- 4.2.5. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:
- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
 - unauthorized use of Government property, theft, vandalism, or immoral conduct;
 - unethical or improper use of official authority or credentials;
 - security violations; or,
 - organizing or participating in gambling in any form
- 4.2.6 Key Control. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system.
- 4.3. Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

4.4. Personnel Security

4.4.1 The work to be performed under this contract requires that the contractor, its employees and sub-contractors submit corporate, financial and personnel information for review by the Embassy. The contractor shall submit this information including service vehicle requirements within 24 hours of the notice to proceed. Contractor must submit a list of personnel with ID type and numbers as well as the vehicle plates and models to the COR and GMTs within 24 hours of notice to proceed. Security clearances must be completed on all personnel prior to being granted access to the DCR. The Government will run background checks on these individuals.

For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Passport number

4.4.2 The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

5. INSURANCE

5.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

5.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

(1) BODILY INJURY, ON OR OFF THE SITE, IN U.S. DOLLARS

(2) PROPERTY DAMAGE, ON OR OFF THE SITE, IN U.S. DOLLARS

5.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

5.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

5.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

5.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

5.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

5.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within five (5) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

6.0. LAWS AND REGULATIONS

6.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the

Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

6.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

7.0. TRANSITION PLAN

Within five (5) days after contract award, the Contracting Officer may request that the Contractor develop a plan for preparing the Contractor to assume all responsibilities for services according to Scope of Work. The plan shall establish the projected period for completion of all clearances of Contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

9.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

The services being performed hereunder and the supplies furnished will be inspected from time to time by the COR, or his/her authorized representatives which is referred to as the GTM, to determine that all work is being performed in a satisfactory manner, and that all supplies are of acceptable quality.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such an inspection.

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

9.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

9.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

9.3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
