Your proposal must be submitted in a sealed envelope marked "Proposal Enclosed" to the GSO Contracting Office at 4 Igor Sikorsky str. by 16:00 on March 14, 2016. No proposals will be accepted after this time.

Complete the Standard Form 1442 and have the form signed by an authorized representative of your company, or the proposal may be considered unacceptable and may be rejected.

In order for a proposal to be considered you must also complete and submit the following:

1. Section A: Price
2. Documents indicated in section J: Quotation Information
3. Section L: Representations, Certifications and other Statements of Offerors or Quoters

The contract will be a firm-fixed price contract, with no adjustment for any escalation in costs or prices of labor or materials. Each offeror will be responsible for determining the amount of labor and materials that will be required to complete the project, and for pricing in its proposal accordingly.

Please be advised that each offeror is responsible for furnishing complete information to its subcontractors and suppliers, such as details and quantities required by the drawings and specifications. Subcontractors and suppliers should not be referred to the Embassy for determining the amount or quantities of materials required.

The Contracting Officer reserves the right to reject any and all proposals and to waive any informality in proposals received. In addition, the Embassy reserves the right to establish a

competitive range of one or more offerors and to conduct further negotiations concerning price and other terms before awarding the contract, or to award without discussions.
