I. SCOPE OF WORK

There will be indefinite quantity/indefinite delivery, firm-fixed price contract. The contractor shall provide trash removal services under the program of trash separation for its disposal and recycling.

MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of USD 900.00. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed USD 32,000.00. This reflects the contract maximum for this period of performance.

II. PRICING

1. Specifications

**General Intent**

The US Embassy in Kyiv, Ukraine implements a program of trash separation for its waste disposal to encourage and support recycling efforts in Ukraine. This program must be competitive in price with waste removal services which do not provide recycling services.

**Program Operation**

The Embassy will collect waste and trash inside of embassy facilities and deposit into contractor provided containers located outside the facilities served. The Embassy will make good effort to insure that waste and trash are separated in compliance with program requirements. The contractor shall remove waste from exterior containers on an agreed schedule and transport for proper disposal.

**Program Requirements**

1. Description of waste types:
  - a. Recyclable Waste: All materials normally suited to recycling within the local economy. Examples: paper (newspaper, magazines, office copy paper, card board); glass; metals (all types); plastic.
  - b. Non-Recyclable Wastes: All materials not suited to recycling. Examples: food; wood; bathroom hand towels, plastic drinking cups, garden trash.
2. The contractor shall provide large waste containers in quantity indicated at each embassy location served. Containers shall be provided for two purposes. One type shall be for non-recyclable waste and trash; and the second type shall be for collection of all types of recyclable wastes. Containers shall be approximately one cubic meter in volume, designed for exposure to all weather, covered, lockable, fitted with wheels and clearly identified for use with recyclable wastes or use with non-recyclable wastes. Containers shall be provided in locations and quantities as listed in chart.

Quantity and type of containers may be adjusted by the embassy as the needs change. Cost quotation shall be based on cost of service per container.

3. Containers shall be emptied by the contractor on the following schedule. Waste pick up schedules are subject to revision as conditions and embassy requirements change. The contractor shall insure that containers accessible to non-embassy persons are locked after waste is emptied. The contractor shall insure that containers are kept in good repair and cleaned inside and outside as necessary. There shall be no additional charge for maintaining and cleaning of containers. The contractor shall pick up any waste spilled on the ground during waste removal and shall pick up and remove all bagged waste not fitting in full containers:
  - a. 4 Sikorskogo blvd: Containers will be located inside embassy controlled space. Contractor shall empty containers two times per week. Embassy personnel shall provide access to containers on embassy approved schedule.
  - b. 5 Pokrovska St: Containers will be located inside embassy controlled space. Contractor shall empty containers two times per week. Embassy personnel shall provide access to containers on embassy approved schedule.
  - c. 19 Nizhniy Val St: Containers will be located on public street and fully accessible at all times. Contractor shall empty containers five times per week before start of business day Monday through Friday.
4. The Contractor is required to provide the Embassy staff with initial training (with no additional cost to the Embassy) on how to operate under the trash separation program.
5. The Contractor shall designate a Project Manager who will be the point of contact for the trash pick-up and recycling services contract. The Project Manager shall be responsible for managing the work and ensuring a smooth and effective operation.

The Contractor should provide the Embassy with a Dispatcher telephone number which is reachable 24 hours a day.

6. If the Contractor failed to perform scheduled trash pick up due to the fact of Contractor's fault, negligence, vehicle breakage or road accident, the Contractor shall ensure the trash pick-up on the same scheduled day by other trash truck at a nearest possible time – **at no cost to the Government.**
7. The Contractor is required to provide a system of trash pick-up control. The Contractor's offer a system of control using employee signature, numbered tickets or other method agreed to by the contractor and the embassy. The monthly invoice shall be based on the information collected in the trash pick-up control system.

3. Personnel requirements

3.1 Removal of Personnel

The Contractor shall maintain discipline at the site and at all times take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or among those employed at the site and for the preservation of peace and protection of persons and property in the neighborhood of the project against the same. The Contracting Officer may require, in writing that the Contractor remove from the work any employee that the Contracting Officer deems incompetent, careless, insubordinate or otherwise objectionable, or whose continued employment on the project is deemed by the Contracting Officer to be contrary to the Government's interests.

3.2 Notice to the Government of Labor Disputes

If the Contractor has knowledge that any actual or potential labor dispute is delaying or threatens to delay the timely performance of this contract, the Contractor shall immediately give notice, including all relevant information, to the Contracting Officer.

3.3 Personnel Security

After award of the contract, the Contractor has five calendar days to submit to the Contracting Officer a list of workers and supervisors assigned to this project for the Government to conduct all necessary security checks. It is anticipated that security checks will take 20 days to perform. For each individual the list shall include:

Failure to provide any of the above information may be considered grounds for rejections and/or re-submittal of the application.

1.4 Language Proficiency

The manager assigned by the contractor to superintend the work on-site, as required by FAR 52.236-6, "Superintendence by the Contractor", shall be fluent in written and spoken English.

2. Insurance

The Contractor shall obtain any types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims. The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, and employees, or any other person, arising from and incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising therefrom, except in the insurance of gross negligence on the part of the Government. The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

3. Law and Regulation

The Contractor shall, without additional expenses to the Government, be responsible for complying with all laws, codes, ordinances, and regulations applicable to the performance of the work, including those of the host country, and with the lawful orders of any governmental authority having jurisdiction.

4. Quality Assurance and Surveillance Plan (QASP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

6.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

6.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

6.3 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
