MASS MEDIA MONITORING SERVICES

1. SCOPE OF SERVICES

The Contractor shall provide Media monitoring services for the U.S. Embassy in Kyiv in accordance with Section 1 - Description/Specifications/Work Statement.

For each year of the contract, the U.S. Government guarantees a minimum order of **USD 1,000.00**. The maximum amount of media monitoring services each year of this contract will not exceed **USD 100,000.00**.

Individual purchases shall be documented via issued a separate funded task order for each services request.

2. PERIOD OF PERFORMANCE

After contract award the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

3. PRICING

The rates below shall include all direct and indirect costs, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The prices include all expenses and materials required to complete the work.

For satisfactory performance of all the scheduled service required under this contract, the contractor shall be compensated monthly for the services performed during that month, at the rates listed hereunder.

3. A. VALUE ADDED TAX

A. A Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to 20% of VAT; this percentage is multiplied only against that portion. It is reflected for each performance period in solicitation.

B. OFFERS AND PAYMENT IN U.S. DOLLARS - U.S. firms are eligible to be paid in U.S. dollars. U.S. firms desiring to be paid in U.S. dollars should submit their offers in U.S.

dollars. A U.S. firm is defined as a company which operates as a corporation incorporated under the laws of a state within the United States.

C. FOREIGN FIRMS - Any firm, which is not a U.S. firm, is a foreign firm. Any firm that does not meet the above definition of U.S. firm shall submit its prices and receive payment in local currency.

1. WORK STATEMENT

1.2 General: The contractor shall provide Mass Media monitoring services for the U.S. Embassy in Kyiv. The contractor shall furnish all managerial, administrative, direct labor personnel, materials and transportation that are necessary to accomplish all work as required by this contract. Performance requirements for required work are described below.

1.2 Personnel: The contractor shall ensure that all personnel assigned to this contract possess the skills and experience necessary for accomplishing their individual tasks.

1) Mass Media Monitoring

Media monitoring of TV stations, radio, newspapers, magazines, Facebook and Twitter on a daily basis (24/7) with delivery of Mass Media monitoring report by 7 am the following day, E-mail delivery as per key words and topics (at least 10), such as:

- U.S. Embassy Kyiv, Ukraine
- Ambassador (name of ambassador – currently Geoffrey Pyatt)
- United States - Ukraine / Economic relations
- United States - Ukraine / Bilateral political relations
- United States - Ukraine / Cultural relations
- United States - Ukraine / Military relations
- U.S. Assistance (donations)
- NATO
- European Union
- United States – Global issues
- Anti-Terrorist Operation

- Russian separatists (all names used to describe)
- Russian-Ukrainian peace talks (e.g. Minsk process)
- Corruption

U.S. Embassy (hereafter named “PAS”) will provide updated lists of key words and topics as necessary. Listed above topics are provided as an example.

Offerors must provide their full lists, and access to, monitored Ukrainian-based national and local (municipal) TV, radio, online, and print media for the last two years.

Media monitoring should cover programs listed below as well as up to two programs per week considered to be of interest to PAS (per request). At a minimum, offerors must monitor/report on the following (times and programs subject to change):

Inter newscasts on weekdays: 7:00, 9:00, 14:00, **20:00** (Podrobnosti, Russian)
 Inter Saturday newscasts: 9:30, **20:00** (Podrobnosti, Russian)
 Inter Sunday newscasts: 9:30, **20:00** (Podrobnosti nedeli, Russian)

Studio 1+1 newscasts weekdays: 6:00, 9:00, 12 noon, **19:30** (main newscast)
 Sat: 7:15, **19:30** (main newscast)
 Sun: 10:00, **19:30** (TSN Tyzhden – TSN Week)

Channel 5 newscasts – every hour, including **20:00 Chas.Pidumsky Dnya news and discussion show** with newscast at 21:00

Also provide a brief summary of the 3-4 leading stories in the television evening news programs.

2) Transcripts Clipping Delivery

Deliver transcripts of TV evening news (in bold above) to an unlimited number of the Government’s e-mail addresses in e-mail format.

E-mail them by 7 am the following day, seven days a week.

Post clipping files (avi/.mpeg for video files) on the vendor-provided .ftp location if requested by PAS.

Urgent delivery of video clipping (DVD) via express courier service, at the expense of PAS, if requested by PAS.

3) Online Database

Provide access to a web-based database with selected filters (search engines) such as descriptor (Positive, Negative, Neutral), media, column, type of media: TV, Facebook or Twitter, date, type of report, topic or word, headline, etc. Online database should cover

at least 12-month before the search, current date (for example: Search on 10-30-2015 should cover 30 October 2014 – 30 October 2015).

4) Archive

Permanent storage of the PAS archive (full back up of A/V files) on the vendor's storage hard drives. Offerors must provide specifications of a storage solution, including manufacturer, HDD capacity, and date of purchase.

Provide delivery of TV pieces from the archive on request (up to 30 requests per month) by PAS.

Offerors must indicate how old their existing clipping archive is.

5) Email-based Service "Alerts"

Provide email alerts with breaking news that report about dramatic and sudden events such as violence against American interests, military offensives in the East, demonstrations in Ukraine, car accidents involving U.S. personnel, etc. Sample: "Ukrainian President announces major offensive against Russian-backed separatists."

6) International media article emailing

Provide full text of international English-language print and online articles relevant to Ukraine and Russia via email (sample subject line: "NYT: U.S. Considers Supplying Arms to Ukraine Forces, Officials Say"). Covered media must include New York Times, Wall Street Journal, Financial Times, Washington Post, Los Angeles Times, The Guardian, BuzzFeed, Mashable, BBC News Online, and Kyiv Post.

7) Misc.

Vendor will have a special designated operator for urgent requests available to the client 24 hours-a-day 7 days-a-week (24/7)

8) Mass media monitoring reports requested by the US Government, once they are produced for the US Government needs, become the sole property of the United States Government for any purpose and shall not be resold or transferred to the third parties.

2. WORK SCHEDULE

The contractor agrees that he shall execute each individual order with a maximum delay of **ONE day** after the receipt of a written advance notice from the Embassy. The contractor will further fully respect all work schedules established between the Contracting Officer's Representative (COR) and the contractor. In case the contractor

fails to respect the work schedule indicated above, he shall be liable to reimburse the Government, except for delays caused by the Government, or due to events over which the contractor has no control (e.g. Acts of God, strikes, civil turmoil...).

3. MANAGEMENT AND SUPERVISION

3.1. **Management:** The contractor shall designate a Project Manager who shall be responsible for handling all business with the Embassy.

3.2. **Supervision:** This Project Manager shall be responsible for the supervision of contractor's work during all times that services are being delivered under this contract. This person shall be the focal point for the contractor and shall act as liaison between the US Embassy personnel. He shall have sufficient English language skill to be able to communicate with members of the US Embassy staff.

3.3. **Quality Control:** Shall be the responsibility of the contractor.

4. INVOICES AND PAYMENT

(a) Individual invoices shall be submitted for each order, accompanied by the task order and indicted task order number on the invoice. Invoices shall be submitted in the original with three (3) copies to the Contracting' Officer's Representative (COR) at the following address (designated payment office only for the purpose of submitting invoices):

The Contractor shall show Value Added Tax (VAT) as a separate item on invoices submitted for payment.

5. KEY PERSONNEL

The Contractor shall assign to this contract the following key personnel.

The Project Manager shall be fluent in the English language. During the first 90 days of performance, the Contractor shall make no substitutions of key personnel unless the substitution is necessitated by illness, death, or termination of employment.

6. PERMITS

At no cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the prosecution of work. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws.

The Contractor shall provide evidence of possession or status of application for such permits, licenses, and appointments to the Contracting Officer with its proposal.

7. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

Monitoring Performance

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

Standard

The performance standard is that the Government receives no more than one (1) **one** customer complaint is received per month customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause, FAR 52.212-4 Contract Terms and Conditions-Commercial Items, if any of the services exceed the standard.

8. PROCEDURES

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection Clause.

- (a) Section 8(a) of the U.S. Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)), prohibits compliance by U.S. persons with any boycott fostered by a foreign country against a country which is friendly to the United States and which is not itself the object of any form of boycott pursuant to United States law or regulation. The Boycott of Israel by Arab League countries is such a boycott, and therefore, the following actions, if taken with intent to comply with, further, or support the Arab League Boycott of Israel, are prohibited activities under the Export Administration Act:

- person;
- (3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person;
 - (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;
 - (5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,
 - (6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.
- (b) Under Section 8(a), the following types of activities are not forbidden "compliance with the boycott," and are therefore exempted from Section 8(a)'s prohibitions listed in paragraphs (a)(1)-(6) above:

thereof, of carriers, insurance, suppliers of services to be performed within the boycotting country or specific goods which, in the normal course of business, are identifiable by source when imported into the boycotting country;

(e) Should the rates for DBA insurance coverage increase or decrease during the performance of this contract, the Contracting Officer shall modify this contract accordingly.

(f) The Contractor shall demonstrate to the satisfaction of the Contracting Officer that the equitable adjustment as a result of the insurance increase or decrease does not include any reserve for such insurance. Adjustment shall not include any overhead, profit, general and administrative expenses, etc.

(g) (1) Section 16 of the State Basic Authorities Act (22 U.S.C. 2680a), as amended, provides that the Defense Base Act shall not apply with respect to such contracts as the Secretary of State determines are contracts with persons employed to perform work for the Department of State on an intermittent basis for not more than 90 days in a calendar year. "Persons" includes individuals hired by companies under contract with the Department. The Procurement Executive has the authority to issue the waivers for Contractor employees who work on an intermittent or short-term basis.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (1) Discriminating in the award of subcontracts on the basis of religion.
