

**REQUIREMENTS ON THE INTERNET LEASE LINE SERVICE FOR THE US EMBASSY HANOI**  
**01 July 2016 – 30 June 2017**

**1. Point-to-Point Leased Line:**

- Bandwidth: 100 Mbps
- Fiber Optic Leased Line

**2. Point-to-Point Leased Line:**

**3. Internet Leased Line:**

- Subnet: Minimum of four public Internet routable addresses from their Internet address. This requires a masking block from subnet of /24 through /29 (I.E. /24, /25, /26, /27, /28 OR /29). It shall not be filtered or block for any ipsec ports or protocols.

- Subnet: /28 subnet, static Public IP addresses for VPN equipment, "always on", NO Network Address Translation, permit all IP protocols (including but not limited to UDP, TCP, and IPSEC) to transit without filters or proxies. Unfiltered access to the Internet is required without ISP firewall blocking. Must permit ping and trace route traffic from 169.252.0.0/16 and 169.253.0.0/16 to the ISP connection.

**PROCUREMENT TERMS & CONDITIONS:**

1. The Offeror must be willing to accept Purchase Order (PO) from US Embassy Hanoi.
2. Vendor's contract is not accepted and signed.
3. All items bid must meet or not to exceed specifications listed.
4. Quotations must be in local currency VND, firm fixed price to include tax and any other anticipated charges.
5. Selected vendor must be able to accept payment made through Electronic Fund Transfer (EFT) to the bank account (VND) as stated on the invoice within 30 (thirty) days after the orders are delivered completely, and the receipt date of original correct invoice. Payments are definitely made on the monthly/quarterly/annually basis.
6. Any cancellation after PO acceptance, only services rendered will be paid.
7. For US Government rules and regulation reference, please read the attached Commercial Clause document.
8. DUNS/SAM registration is mandatory as instructed in Invitation Letter.
