QUALIFICATION REQUIREMENTS

NOTE: All applicants are instructed to address each selection criterion detailed below with specific and comprehensive information supporting each item.

(1) Completion of secondary school is required. **(2)** Must have basic knowledge of first aid, emergency drills, and fire fighting equipment. **(3)** Must be knowledgeable of local law regarding arrest, detention, self-defense and the use of force. **(4)** Must be able to deal with visiting members of the public in a courteous, respectful and firm manner. Must be able to follow instructions and be reliable in attendance and performance. **(5)** Level 2 (Limited Knowledge) Speaking/Reading/Writing English is required (this will be tested). Level 4 (Fluent) Speaking/Reading/Writing Vietnamese is required.
