Dr. David Brewster is a Visiting Fellow with the Strategic and Defence Studies Centre, Australian National University, a Fellow with the Australia India Institute and Senior Maritime Security Fellow with the Indian Council on Global Relations. He has written extensively on India's security relationships throughout the Asia Pacific and the Indian Ocean region. His books include *India as an Asia Pacific Power* which explores India's growing security relationships and ambitions in the Asia Pacific. His most recent book, *India's Ocean: the Story of India's Bid for Regional Leadership*, examines India's strategic aspirations and relationships in the Indian Ocean region. He is the author of numerous academic articles on Indian and Indian Ocean security affairs in international journals including *Asian Security*, *Pacific Review*, *India Review*, *Contemporary South Asia*, *Journal of Strategic Studies*, *Asian Survey*, *Security Challenges*, *Australian Journal of International Affairs*, and *Journal of the Indian Ocean Region*. He was one of the principal authors of *The Indian Ocean Region: Security, Stability and Sustainability in the 21st Century*, which analysed the security environment in the Indian Ocean and proposed strategies for dealing with the changing balance of power in the region. He is also the author of a recent report by the Indian Council on Global Relations titled *The India-Australia Security Engagement: Opportunities and Challenges*. This explores Indian and Australian perspectives on Indian Ocean security and provides policy recommendations for greater security engagement between those countries.

Her most recent research includes the impact of IUU fishing regulations on international fish trade, combating transnational crime in fisheries, security of fishing vessels in disputed areas, and implementing fisheries-related labor conventions. Mary Ann also coordinates the UOW ANCORS' postgraduate coursework programs which cater primarily to defence, enforcement and fisheries policy officers. Her teaching commitments include international fisheries law, comparative ocean law and policy, fisheries development, international fish trade and integrated monitoring, control and surveillance.

Vice Admiral Muralidharan retired as 19th Director General of Indian Coast Guard in Feb 2013. An alumnus of National Defence Academy, Khadakvasla, he was commissioned into the Indian Navy on 01 Jan 1975. A specialist in Navigation and Direction, he is also a graduate of Defence Services Staff College, Wellington (India). In a career of almost four decades, the Admiral has held several key Operational and Staff appointments. He has commanded three warships including the Guided Missile Destroyer Ranvijay and has been Fleet Operations Officer of the Western Fleet and Principal Director of Naval Operations at the Integrated Headquarters of the Ministry of Defence (Navy). He was also Naval Assistant to the Chief of the Naval Staff and Naval Attaché, at the Embassy of India, Moscow. On elevation to Flag Rank, as Rear Admiral he was the Flag Officer Sea Training at Kochi; Chief of Staff, Western Naval Command at Mumbai and also held the operational appointment of the Flag Officer Commanding, Maharashtra and Gujarat Naval Area. On promotion to Vice Admiral, he became the first Commandant of the Indian Naval Academy, at Ezhimala and later the Chief of Personnel at Naval Headquarters prior to taking over as Director General of the Indian Coast Guard. Inspector General S. P. Sharma, a second batch officer joined the Indian Coast Guard in 1980 and assumed Command of Coast Guard Region (East) in December 2010. A post graduate in Physics and Telecommunications, he specializes in naval communication systems and is an alumnus of the College of Defence Management, Secunderabad.
