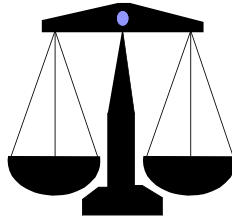

The Barcelona Consular District covers the provinces of **Barcelona, Gerona, Huesca, Lérida, Tarragona, Teruel, the Balearic Islands, Zaragoza, and the Principality of Andorra**. This list has been divided into sections, grouped by countries, autonomous communities, provinces and cities.

At the present time, the rate of first-class air mail from the United States to Spain is: 90 cents for the first ounce and 90 cents or fraction thereof. Registered mail may be sent through the Spanish postal services and return receipts obtained. International reply coupons should be used when it is desired to prepay a reply.

Credit reports can be obtained through banks or through commercial reporting agents such as Dun and Bradstreet, Inc. whose Spanish headquarters are located in Madrid.
