A. **CONSULAR DISTRICT:** The Consular District of the United States Embassy in Guatemala City includes all of the Departments (Departamentos) in Guatemala. The attached list provides biographic data for attorneys, listed alphabetically.

1. **KNOWLEDGE OF ENGLISH:** Each attorney was requested to indicate his ability to speak English. Except as otherwise indicated, those attorneys who indicated they could not speak English were not included in this list.

2. **SPANISH NAMES:** Under the Spanish tradition of presenting the word order of names, the first and middle names are shown in the usual order. The family name (i.e. the name of the father) is then shown and serves as the basis for determining alphabetical order. The last name shown is the family name of the mother. Our list shows the family name in capital letters. When writing to David COFFEY Aparicio, for example, he should be addressed as "Dear señor Coffey". Do not use: "Dear señor Aparicio".

3. **CITIZENSHIP:** Every attorney listed is a Guatemalan citizen and was born in Guatemala unless otherwise indicated.

4. **ADDRESS INFORMATION:** Should you wish to write to one of the attorneys, you should use the following format on your envelope:

5. **POSTAL RATES FROM UNITED STATES TO GUATEMALA:** Letters (considered 1<sup>st</sup> class mail): Half ounce \$0.80. Registered: May be sent through Guatemalan postal service and return receipts obtained. Insurance: None for letters and letter packages. The postal service in Guatemala is improving, but can be unreliable. For this reason, we recommend sending important documents by a private courier, such as Federal Express or DHL.

6. **TELEPHONE SERVICE:** To place a telephone call from the United States, dial 011, followed by "502" (the country code for Guatemala), followed by the local eight-digit number you wish to reach. Alternatively, obtain the assistance of your Long Distance Operator who can place the call for you.

7. NOTARY PUBLIC: Every attorney listed may act as a Notary Public.

8. AUTHENTICATIONS: The name of each attorney listed is on file in the Consular Section of the United States Embassy in Guatemala for purposes of authenticating signatures.

B. CREDIT REPORTS: Credit reports can usually be obtained through banks.

NOTE: Neither the Embassy nor the Department of State can assume any responsibility for the accuracy of any of the data provided, the integrity, or the professional ability of any of the attorneys listed. We suggest contacting several attorneys to discuss your case and the fees involved before deciding which to employ; most Guatemalan attorneys do not charge for this initial consultation.
