

I. SCOPE OF SERVICES

Contractor shall provide two (2) double hotel bedrooms in Port au Prince, Haiti. Contract type will be firm fixed price per room.

Lodging rooms shall include private bath, air conditioning, living room and kitchen area, in the hotel located in the Port-au-Prince metropolitan area. The Government shall be liable for the price of each room ordered but not used, unless the Contracting Officer gave the Contractor an oral or written cancellation no less than one day before the anticipated effective date.

The contract will be for a 4 months period beginning July 12, 2016 and ending November 11, 2016.

1. GENERAL

The Contractor shall provide two (2) double hotel bedrooms to include private bath, living room, kitchen and air conditioning in the Port au Prince Metropolitan Area.

2. ADDITIONAL REQUIREMENTS

The contractor shall be able to provide extra cleaning services and free internet services.

The Government will pay only for the lodging rooms and the traveler will take care of all meals and incidental expenses.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. (a) In accordance with section 7073 of Division K of the Consolidated Appropriations Act, 2014 (Public Law 113-76) none of the funds made available by that Act may be used to enter into a contract with any corporation that –

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government; or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
