

### Gross Domestic Product






## Foreign Currency Reserves

**Jo-Imports:** KSA 17.6%, China 10.3%, USA 6.4%, Italy 4.9%, Turkey 3.8%, Germany 3.7%.

### Major Commodities:


**Jo-Exports:** Medical and pharma products 9%, potash 12%, vegetables 6%, phosphates 7%, fertilizers 3%.
