## **SERVICE OF PROCESS**

American consular officers are prohibited by regulations from serving legal process emanating from any court, whether in the United States or abroad, and are prohibited from appointing others to do so, except in certain cases in the United States Federal courts involving service of process on United States citizens abroad (28USC 1783 and 1784,)

Service of process in the Philippines may be accomplished by various methods (depending on the circumstances of the case, such as by registered mail at last known address, by publications, and personal service which may also be made by other officers of the court, including attorneys. Most American law firms have found it helpful, and in many cases necessary, to engage the service of Philippine attorneys to advise and assist them in effecting service of process in the Philippines.

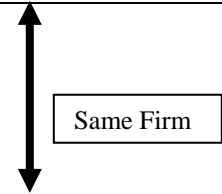
