

# **VACANCY ANNOUNCEMENT**

## **Diversity Enhancement Internship for Romani Students with U.S. Embassy Bratislava**

### **OPEN TO:**

As part of its efforts to support the inclusion of Roma into all aspects of life in Slovakia and encourage increased diversity in the workplace, the U.S. Embassy in Bratislava is launching an internship program for students of Romani origin. The program is also in line with the U.S. Government's diversity enhancement efforts. The applicants must be at least 18 years of age and currently enrolled in an accredited university/college. Only non-U.S. citizens need apply.

**POSITION:** Intern/Local Intern Program

**OPENING DATE:** Ongoing

**CLOSING DATE:** Ongoing

**WORK HOURS:** TBD

**SALARY:** Unpaid

There are no benefits, compensation, or future employment rights attached to the internships. Service is not creditable for leave accrual or any other employee-type benefits.

### **TYPES OF ASSIGNMENTS:**

The student interns will be assigned challenging duties that contribute to their educational and professional development. Duties could include research, economic and political report writing, information systems management, analysis of international issues, public outreach with Slovak entities, procurement of items, receiving into inventory, verifying inventory, proper disposal methods, etc.

## **ELIGIBILITY:**

Only students who are Slovak citizens and non-U.S. citizens are eligible for the Local Intern Program.

The student must be at least 18 years of age, currently enrolled in an accredited university/college full-time study program, and of Romani origin. The Embassy especially encourages students from disadvantaged backgrounds or from marginalized communities to apply.

The student intern must be in good academic standing and provide a certified transcript from their educational institution as verification.

## **RESPONSIBILITIES OF INTERNS:**

Interns are expected to follow all U.S. Embassy regulations regarding conduct and performance. Interns are subject to termination at any time at the discretion of the Embassy.

Each intern must complete and submit the following:

- Application and resume
- Statement of interest form/letter

## **QUALIFICATIONS REQUIRED:**

Applicants must address each selection criterion detailed below with specific information supporting each item in order to be considered qualified.

Education: Present enrollment in a university or college – full time study

Language: Level IV Slovak language skills and Level III English (good working knowledge) are required.

The selected student(s) must **pass a background check** and **receive a security clearance from post RSO** before commencement of the internship.

Interested applicants for the internship must submit:

A current resume or curriculum vitae

Any other documentation (e.g. certificates, awards)
